AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (SARAWAK) (PINDAAN) (NO. 7) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Sarawak, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Sarawak) (Pindaan) (No. 7) 2024**.

(2) Perintah ini mula berkuat kuasa pada 8 November 2024.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Sarawak) 1996 [*P.U. (A) 551/1996*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama di bawah kepala LEBUH RAYA PAN BORNEO, dengan memasukkan selepas butiran (*jo*) butiran yang berikut:

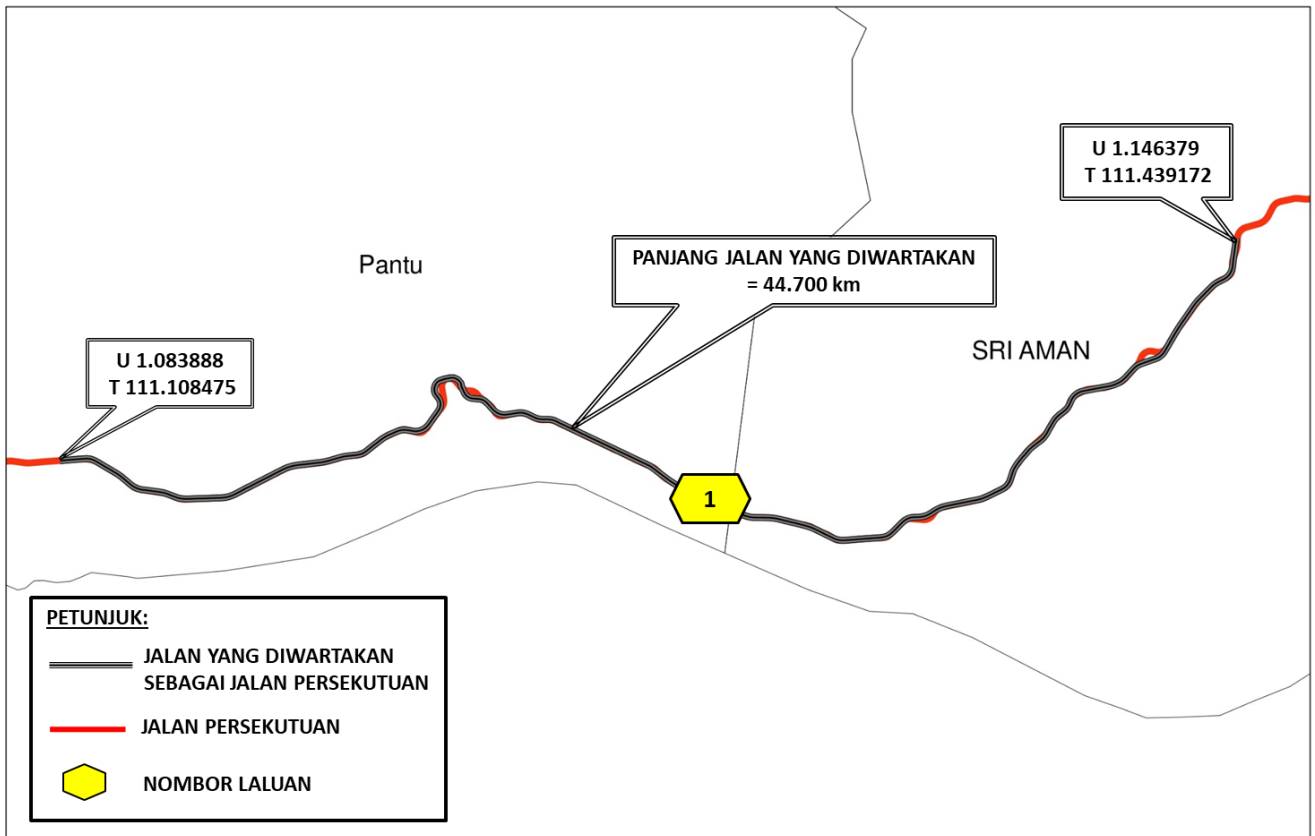
“(jp) (*Laluan 1*): *Simpang Pantu-Jambatan Sungai Entulang*

Bermula di koordinat U 1.083888, T 111.108475 dan berakhir di koordinat U 1.146379, T 111.439172 termasuk jalan sambungannya di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA SIMPANG PANTU-JAMBATAN SUNGAI ENTULANG (jarak sepanjang 44.700 km).”.

Pindaan Jadual Ketiga

3. Perintah ibu dipinda dalam Jadual Ketiga dengan memasukkan selepas PETA JAMBATAN SUNGAI KAYAN ULU-JAMBATAN SUNGAI MOYAN peta yang berikut:

“PETA SIMPANG PANTU-JAMBATAN SUNGAI ENTULANG

FEDERAL ROADS ACT 1959

FEDERAL ROADS (SARAWAK) (AMENDMENT) (NO. 7) ORDER 2024

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Sarawak, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Sarawak) (Amendment) (No. 7) Order 2024**.

(2) This Order comes into operation on 8 November 2024.

Amendment of First Schedule

2. The Federal Roads (Sarawak) Order 1996 [*P.U. (A) 551/1991*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule under the heading PAN BORNEO HIGHWAY, by inserting after item (*jo*) the following item:

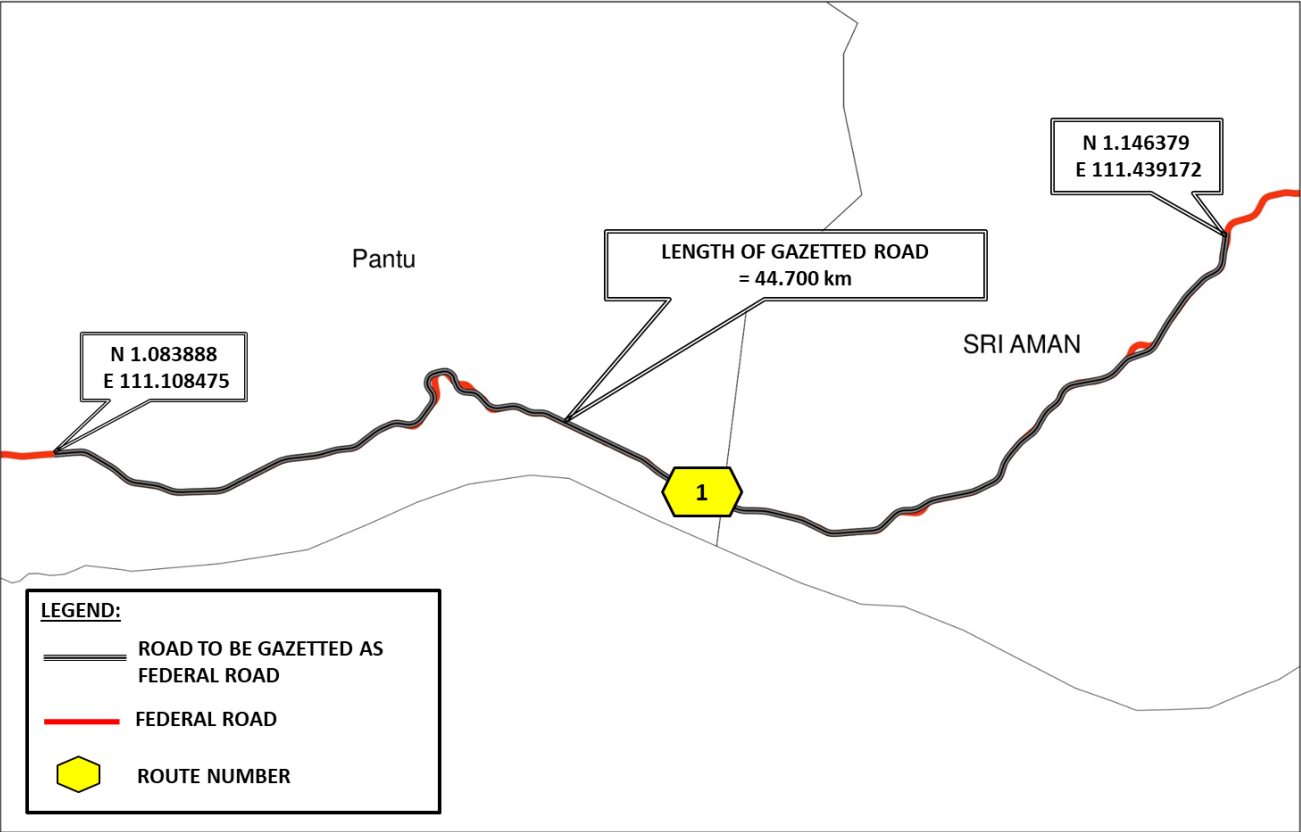
“(jp) (Route 1): Pantu Junction-Sungai Entulang Bridge

Starting at coordinates N 1.083888, E 111.108475 and ending at coordinates N 1.146379, E 111.439172 including its link road within the boundaries of right of way as shown on MAP OF PANTU JUNCTION-SUNGAI ENTULANG BRIDGE (a distance of 44.700 km).”.

Amendment of Third Schedule

3. The principal Order is amended in the Third Schedule by inserting after MAP OF SUNGAI KAYAN ULU BRIDGE-SUNGAI MOYAN BRIDGE the following map:
