PERINTAH JALAN PERSEKUTUAN (SKIM FELDA) (PINDAAN) (NO. 3) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Skim Felda) (Pindaan) (No. 3) 2024**.

(2) Perintah ini mula berkuat kuasa pada 30 Oktober 2024.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Skim Felda) 1991 [*P.U. (A) 449/1991*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama di bawah kepala “Negeri Pahang”—

(a) dengan menggantikan butiran “Tembangau 1 & 2” dan butir-butir yang berhubungan dengannya dengan butiran dan butir-butir yang berikut:

Nama Skim FELDA	Nombor Laluan bagi Jalan Masuk	Jalan Masuk (km)	Jalan Kampung (km)
“Tembangau 1 & 2	1532	2.597	15.679”;

(b) dengan menggantikan butiran “Palong 16-Tembangau” dan butir-butir yang berhubungan dengannya dengan butiran dan butir-butir yang berikut:

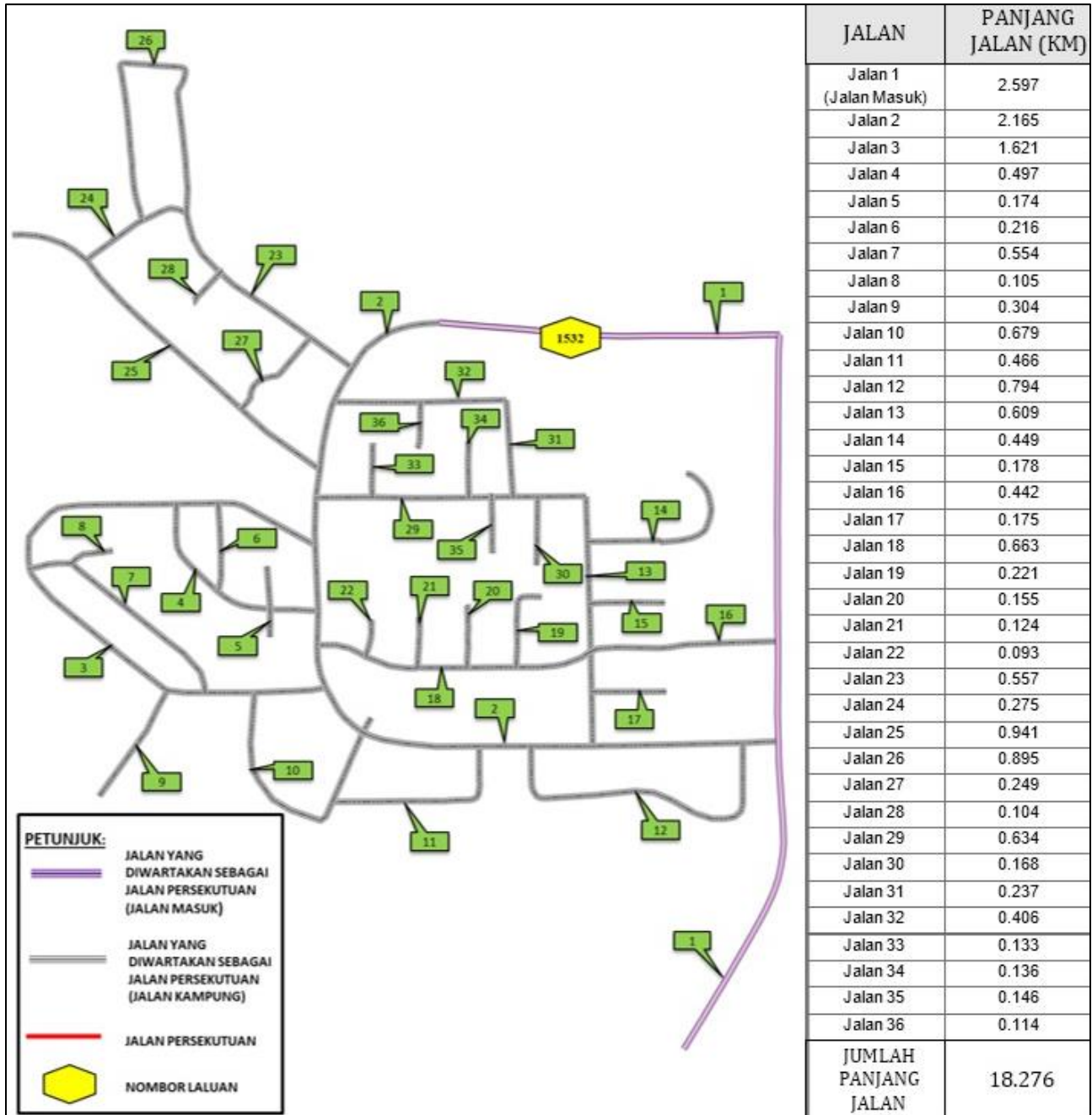

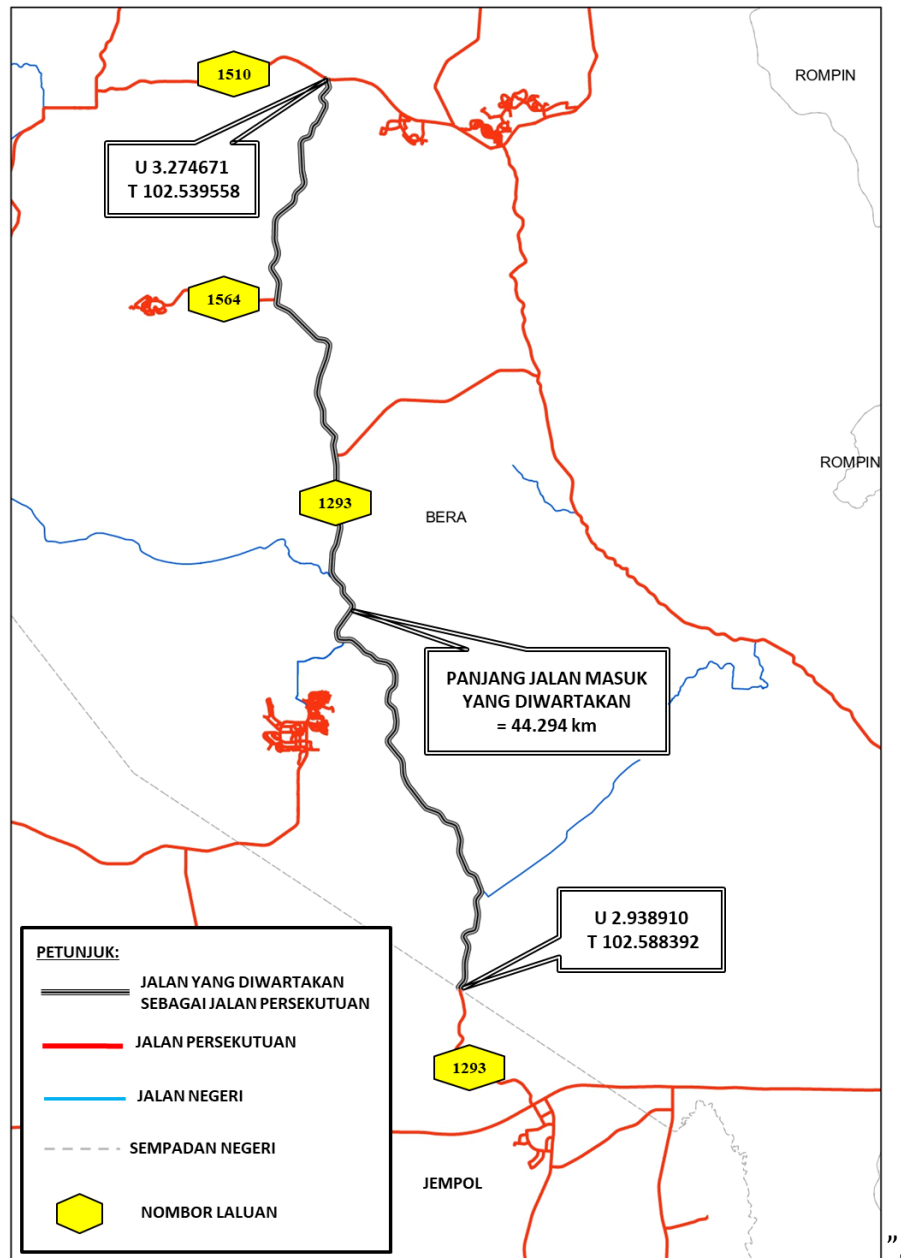

FEDERAL ROADS ACT 1959

FEDERAL ROADS (FELDA SCHEME) (AMENDMENT) (NO. 3) ORDER 2024

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Felda Scheme) (Amendment) (No. 3) Order 2024**.

(2) This Order comes into operation on 30 October 2024.

Amendment of First Schedule

2. The Federal Roads (Felda Scheme) Order 1991 [*P.U. (A) 449/1991*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule under the heading of “State of Pahang”—

(a) by substituting for item “Tembangau 1 & 2” and the particulars relating to it the following item and particulars:

“Tembangau 1 & 2	1532	2.597	15.679”;

(b) by substituting for item “Palong 16-Tembangau” and the particulars relating to it the following item and particulars:

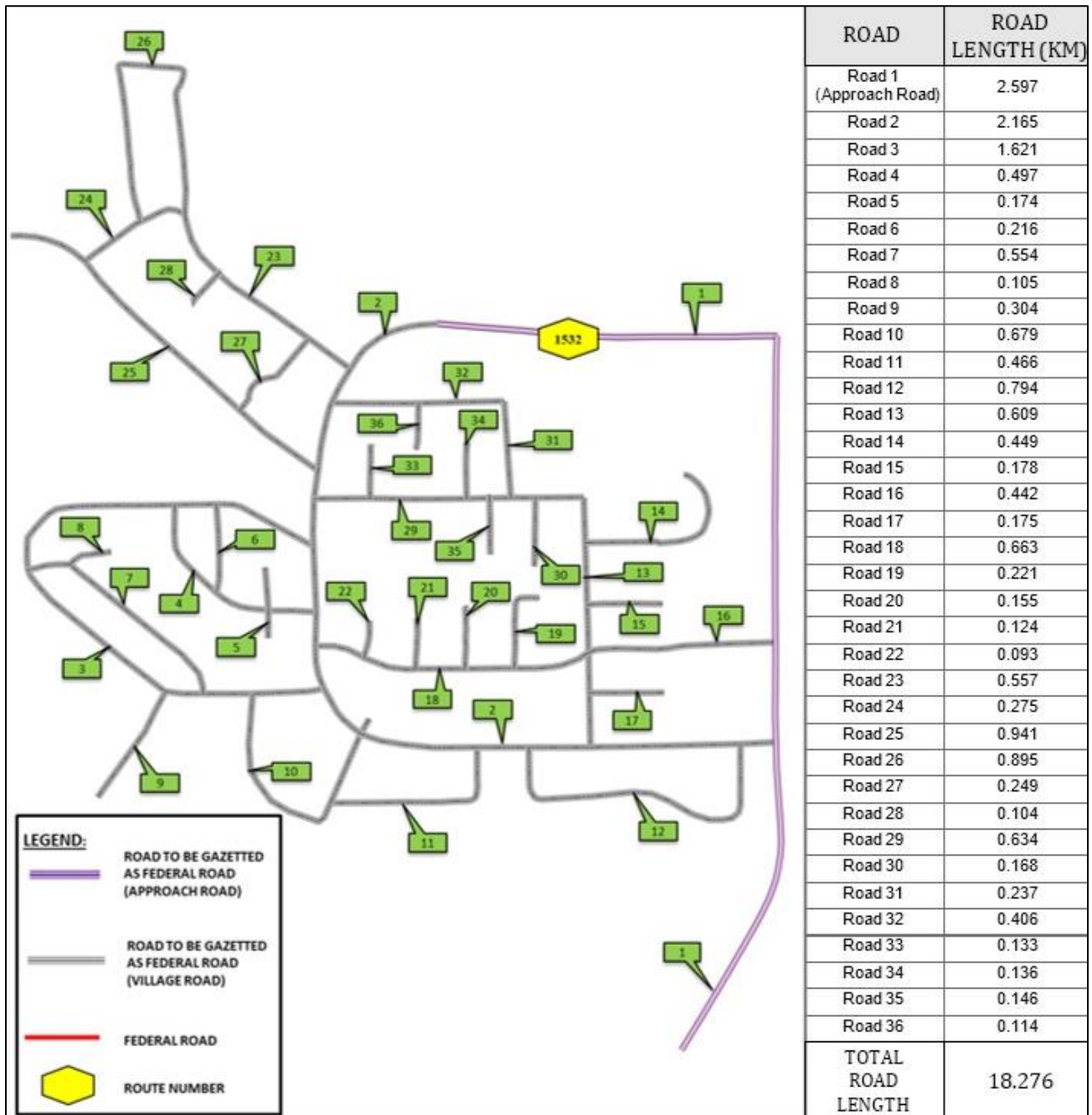

(c) by deleting item “Triang” and the particulars relating to it.

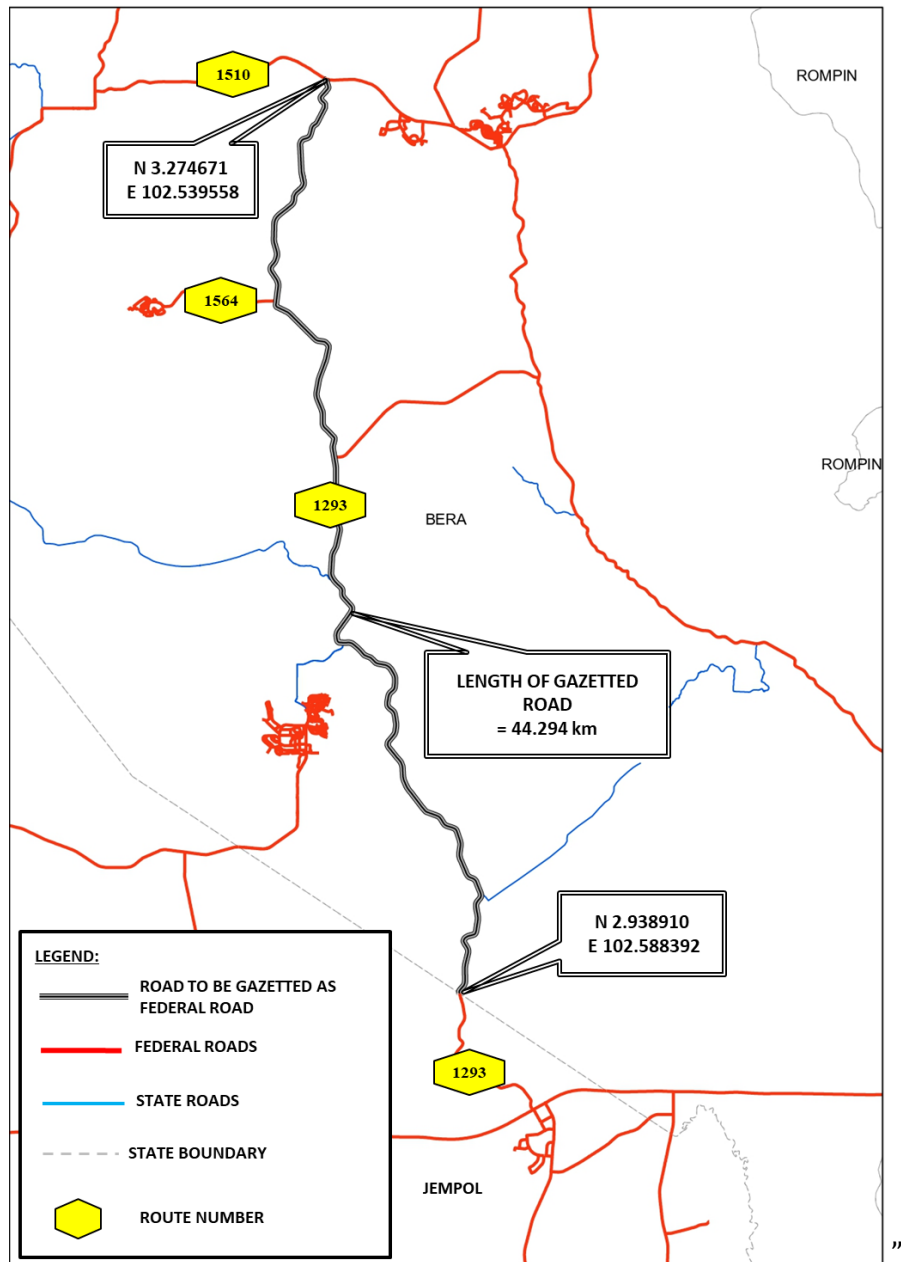
Amendment of Second Schedule
