PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 12) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Perlis, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 12) 2024**.

(2) Perintah ini mula berkuat kuasa pada 30 Oktober 2024.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala Negeri Perlis Indera Kayangan—

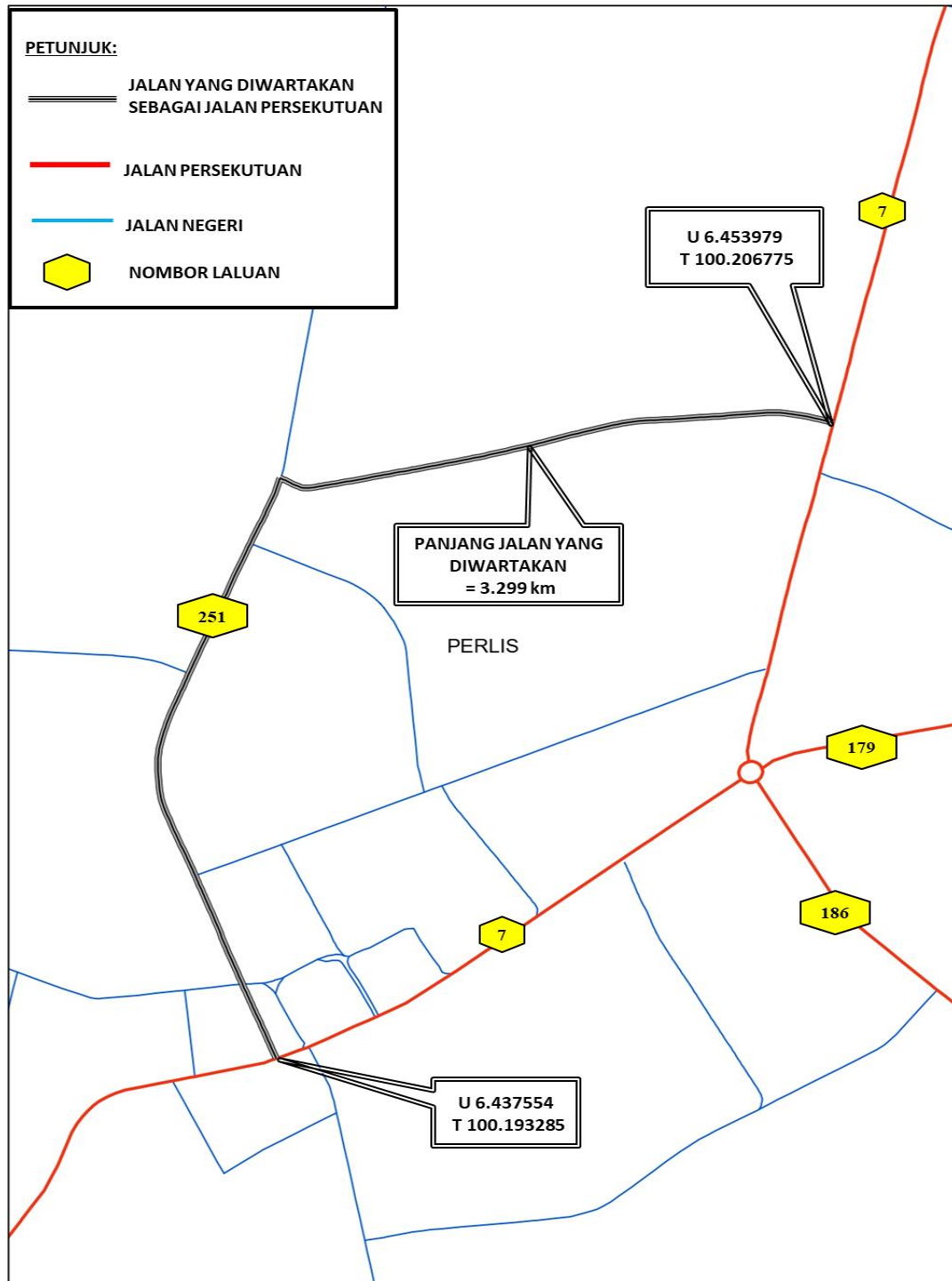
(a) dengan memasukkan selepas butiran 13 butiran yang berikut:

“14. (*Laluan 251*): *Jalan Abi Tok Hashim*

Bermula dari persimpangan Laluan 7, Jalan Kangar-Padang Besar di koordinat U 6.437554, T 100.193285 dan berakhir di Laluan 7, Jalan Kangar-Padang Besar di koordinat U 6.453979, T 100.206775 termasuk jalan sambungannya di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA 13: JALAN ABI TOK HASHIM (jarak sepanjang 3.299km).”; dan

(b) dengan memasukkan selepas PETA 12: JALAN KODIANG-KANGAR peta yang berikut:

“PETA 13: JALAN ABI TOK HASHIM

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 12) ORDER 2024

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Perlis, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 12) Order 2024**.

(2) This Order comes into operation on 30 October 2024.

**Amendment of First Schedule**

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/1989*] is amended in the First Schedule under the heading of Negeri Perlis Indera Kayangan—

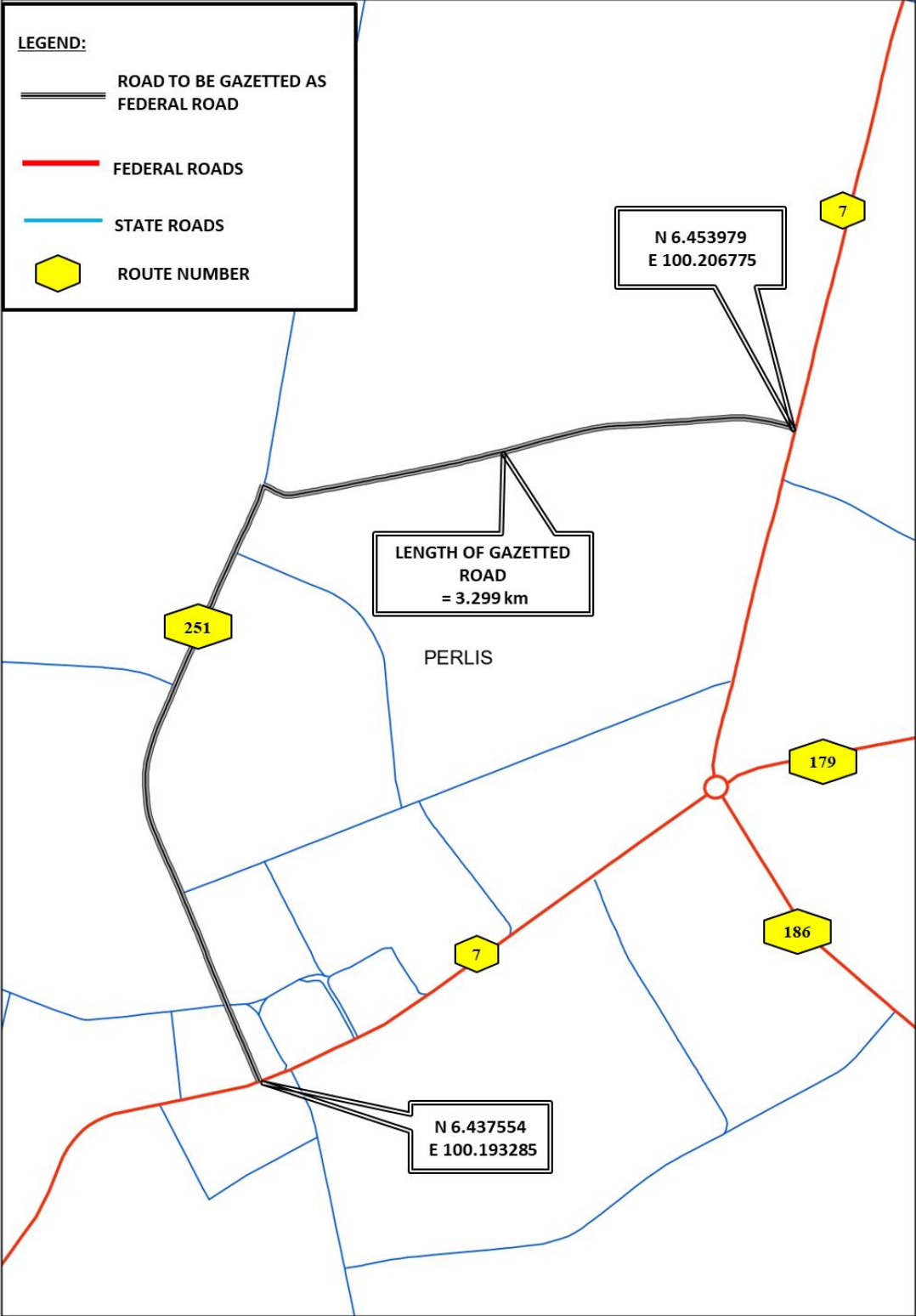
(a) by inserting after item 13 the following item:

“14. (*Route 251*): *Abi Tok Hashim Road*

Starting from the junction of Route 7, Kangar-Padang Besar Road at coordinates N 6.437554, E 100.193285 and ending at Route 7, Kangar-Padang Besar Road at coordinates N 6.453979, E 100.206775 including its link road within the boundaries of right of way as shown on MAP 13: ABI TOK HASHIM ROAD (a distance of 3.299 km).”;

(b) by inserting after MAP 12: KODIANG-KANGAR ROAD the following map:
