IN exercise of the powers conferred by subsection 47(3) of the Control of Smoking Products For Public Health Act 2024 [Act 852], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Control of Smoking Products For Public Health (Notice Under Section 47) Regulations 2024**.

(2) These Regulations come into operation on 1 October 2024.

Notice ordering appearance to court

2. A notice served by the Director General or any authorized officer under subsection 47(1) of the Act shall be in the form as specified in the Schedule.
