PERBADANAN PUTRAJAYA ACT 1995

PERBADANAN PUTRAJAYA
(FINANCIAL AND ACCOUNTING) (AMENDMENT) REGULATIONS 2024

IN exercise of the powers conferred by section 33 of the Perbadanan Putrajaya Act 1995 [*Act 536*], the Perbadanan with the approval of the Minister, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Perbadanan Putrajaya (Financial and Accounting) (Amendment) Regulations 2024**.

(2) These Regulations are deemed to have come into operation on 22 October 2019.
