AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (SARAWAK) (PINDAAN) (NO. 6) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Sarawak, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Sarawak) (Pindaan) (No. 6) 2024**.

(2) Perintah ini mula berkuat kuasa pada 30 Ogos 2024.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Sarawak) 1996 [P.U. (A) 551/1996], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama, di bawah kepala LEBUH RAYA PAN BORNEO, dengan memasukkan selepas butiran (jn) butiran yang berikut:

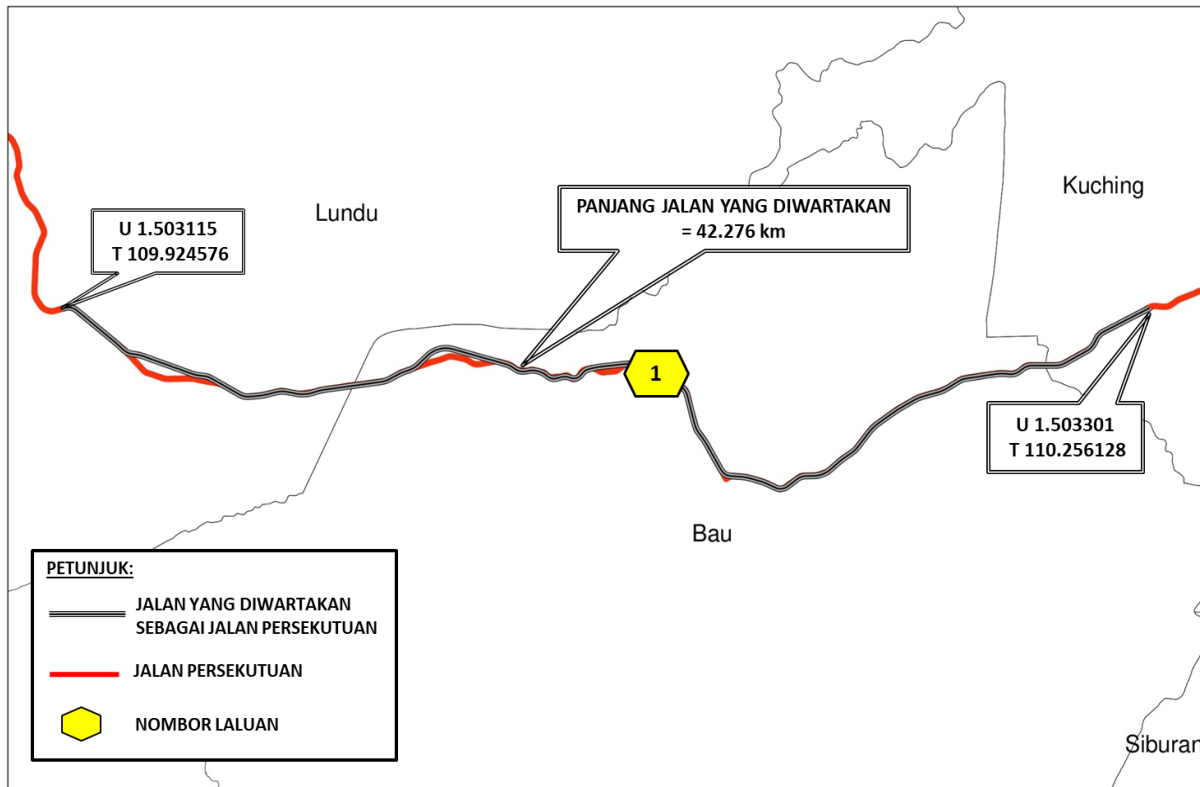
“(jo) (Laluan 1): Jambatan Sungai Kayan Ulu-Jambatan Sungai Moyan

Bermula di koordinat U 1.503115, T 109.924576 dan berakhir di koordinat U 1.503301, T 110.256128 termasuk jalan sambungannya di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA JAMBATAN SUNGAI KAYAN ULU-JAMBATAN SUNGAI MOYAN (jarak sepanjang 42.276 km).”.

Pindaan Jadual Ketiga

3. Perintah ibu dipinda dalam Jadual Ketiga dengan memasukkan selepas PETA LAPANGAN TERBANG SIBU-JAMBATAN SUNGAI KUA peta yang berikut:

“PETA JAMBATAN SUNGAI KAYAN ULU-JAMBATAN SUNGAI MOYAN

FEDERAL ROADS ACT 1959

FEDERAL ROADS (SARAWAK) (AMENDMENT) (NO. 6) ORDER 2024

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Sarawak, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Sarawak) (Amendment) (No. 6) Order 2024**.

(2) This Order comes into operation on 30 August 2024.

Amendment of First Schedule

2. The Federal Roads (Sarawak) Order 1996 [*P.U. (A) 551/1991*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule, under the heading of PAN BORNEO HIGHWAY, by inserting after item (*jn*) the following item:

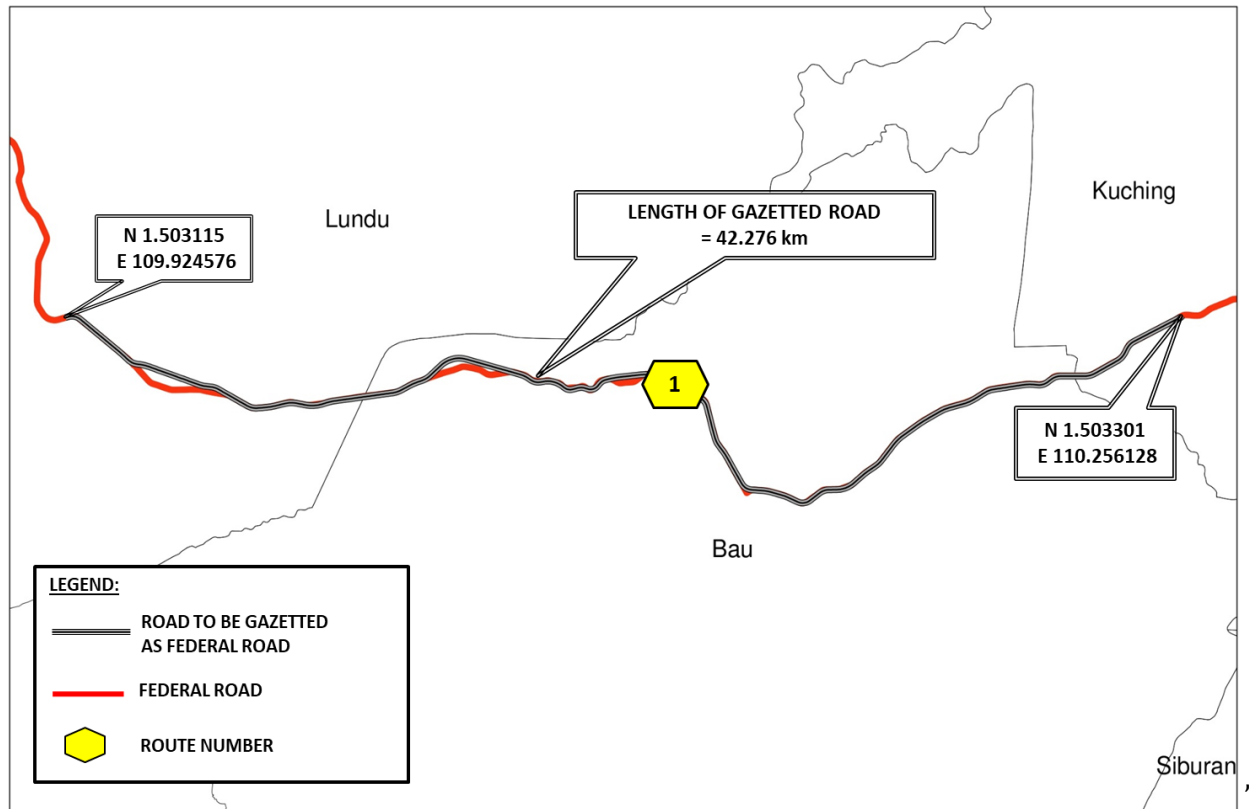
“(jo) (Route 1): Sungai Kayan Ulu Bridge-Sungai Moyan Bridge

Starting at coordinates N 1.503115, E 109.924576 and ending at coordinates N 1.503301, E 110.256128 including its link road within the boundaries of right of way as shown on MAP OF SUNGAI KAYAN ULU BRIDGE-SUNGAI MOYAN BRIDGE (a distance of 42.276 km).”.

Amendment of Third Schedule

3. The principal Order is amended in the Third Schedule by inserting after MAP OF SIBU AIRPORT-SUNGAI KUA BRIDGE the following map:
