PERINTAH DUTI HIBURAN (PENGECCUALIAN) (NO. 5) 2024

PADA menjalankan kuasa yang diberikan oleh perenggan 12(1)(b) Akta Duti Hiburan 1953 [*Akta 103*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Hiburan (Pengeccualian) (No. 5) 2024**.

(2) Perintah ini berkuat kuasa mulai 1 Januari 2024 hingga 31 Disember 2028.

Pengeccualian

2. Menteri mengeccualikan dua puluh peratus daripada duti hiburan yang kena dibayar atas tiket masuk ke Wetland Studios Putrajaya bagi tempoh mulai 1 Januari 2024 hingga 31 Disember 2028.

ENTERTAINMENTS DUTY ACT 1953

ENTERTAINMENTS DUTY (EXEMPTION) (NO. 5) ORDER 2024

IN exercise of the powers conferred by paragraph 12(1)(b) of the Entertainments Duty Act 1953 [*Act 103*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Entertainments Duty (Exemption) (No. 5) Order 2024**.

(2) This Order has effect from 1 January 2024 to 31 December 2028.

Exemption

2. The Minister exempts twenty per cent from the entertainments duty payable on the admission ticket to the Wetland Studios Putrajaya for the period from 1 January 2024 to 31 December 2028.
