AKTA KAWALAN HARGA DAN ANTIPENCATUTAN 2011

PERINTAH KAWALAN HARGA DAN ANTIPENCATUTAN (PENENTUAN CAJ TETAP
BAGI KELAS PERKHIDMATAN PENGENDALI PELANCONGAN BERLESEN) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 5 Akta Kawalan Harga dan Antipencatutan 2011 [*Akta 723*], Pengawal, dengan kelulusan Menteri, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kawalan Harga dan Antipencatutan (Penentuan Caj Tetap bagi Kelas Perkhidmatan Pengendali Pelancongan Berlesen) 2024**.

(2) Perintah ini mula berkuat kuasa pada 10 Julai 2024.

Tafsiran

2. Dalam Perintah ini, “pengendali pelancongan berlesen” hendaklah mempunyai erti yang sama yang diberikan kepadanya dalam Akta Industri Pelancongan 1992 [*Akta 482*].

Caj tetap bagi kelas perkhidmatan pengendali pelancongan berlesen

3. Bagi maksud Program *Malaysia My Second Home (MM2H)*, caj tetap bagi kelas perkhidmatan pengendali pelancongan berlesen yang dinyatakan dalam ruang (1) Jadual bagi peserta yang dinyatakan dalam ruang (2) ditentukan mengikut amaun sebagaimana yang dinyatakan dalam ruang (3).

PRICE CONTROL AND ANTI-PROFITEERING (DETERMINATION OF FIXED CHARGE
FOR CLASS OF SERVICE OF LICENSED TOUR OPERATOR) ORDER 2024

IN exercise of the powers conferred by section 5 of the Price Control and Anti-Profiteering Act 2011 [*Act 723*], the Controller, with the approval of the Minister, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Price Control and Anti-Profiteering (Determination of Fixed Charge for Class of Service of Licensed Tour Operator) Order 2024**.

(2) This Order comes into operation on 10 July 2024.

Interpretation

2. In this Order, “licensed tour operator” shall have the same meaning assigned to it in the Tourism Industry Act 1992 [*Act 482*].

Fixed charge for class of service of licensed tour operator

3. For the purposes of Malaysia My Second Home (MM2H) Programme, the fixed charge for class of service of licensed tour operator specified in column (1) of the Schedule for participant specified in column (2) is determined according to the amount as specified in column (3).
