ROAD TRANSPORT ACT 1987

MOTOR VEHICLES (REGISTRATION AND LICENSING)
(AMENDMENT OF FOURTH SCHEDULE) 2024

IN exercise of the powers conferred by paragraph 66(1)(r) of the Road Transport Act 1987 [Act 333], the Minister makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Motor Vehicles (Registration and Licensing) (Amendment of Fourth Schedule) Rules 2024**.

(2) These Rules come into operation on 1 July 2024.
