AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 5) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Selangor, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 5) 2024**.

(2) Perintah ini mula berkuat kuasa pada 5 Julai 2024.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala Negeri Selangor Darul Ehsan—

(a) dengan menggantikan butiran 37 dengan butiran yang berikut:

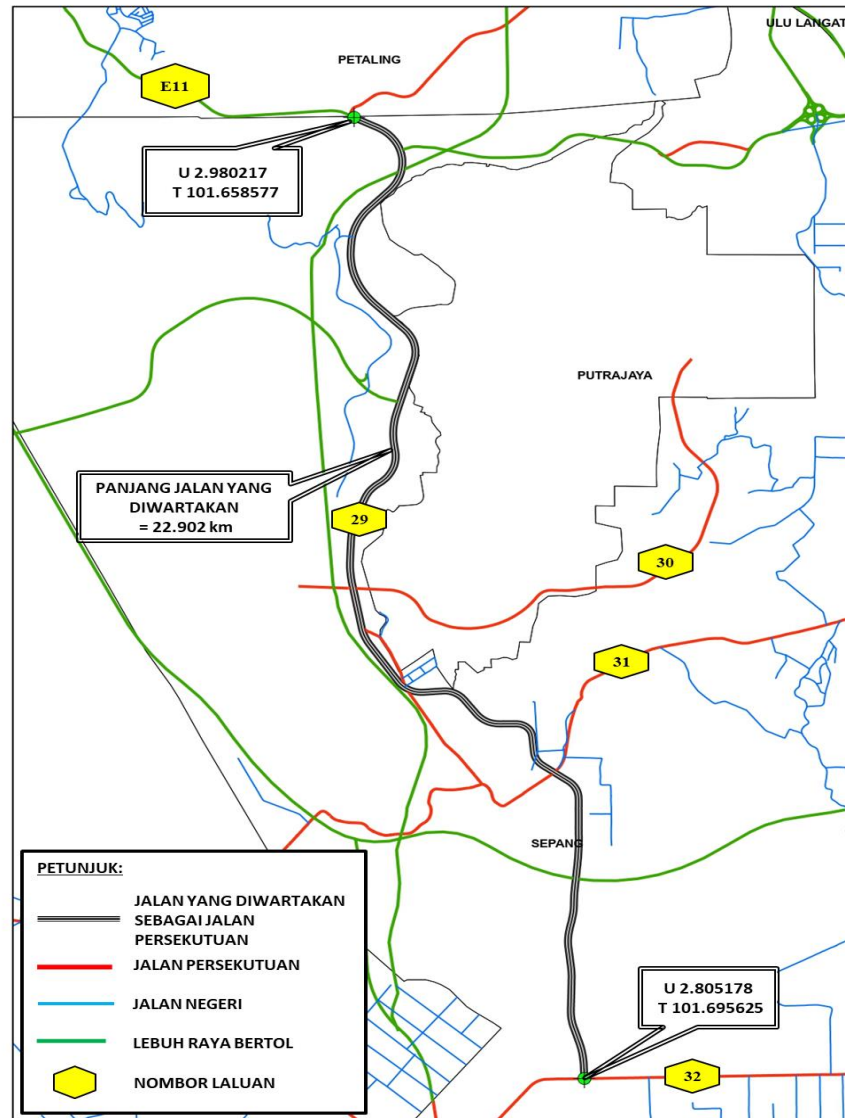
“37. (Laluan 29): *Puchong–Kota Warisan*

Bermula dari penghujung Lebuhraya Damansara Puchong–Putrajaya dan Cyberjaya di koordinat U 2.980217, T 101.658577 dan berakhir di persimpangan Laluan 32, Jalan Labohan Dagang–Nilai di koordinat U 2.805178, T 101.695625 termasuk jalan sambungannya di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA 13: PUCHONG–KOTA WARISAN (jarak sepanjang 22.902 km).”;

(b) dengan memotong butiran 50; dan

(c) dengan menggantikan PETA 13: JALAN-JALAN PERSEKUTUAN NEGERI SELANGOR DARUL EHSAN dengan peta yang berikut:

“PETA 13: PUCHONG–KOTA WARISAN

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 5) ORDER 2024

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Selangor, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 5) Order 2024**.

(2) This Order comes into operation on 5 July 2024.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/1989*] is amended in the First Schedule under the heading of Negeri Selangor Darul Ehsan—

(a) by substituting for item 37 the following item:

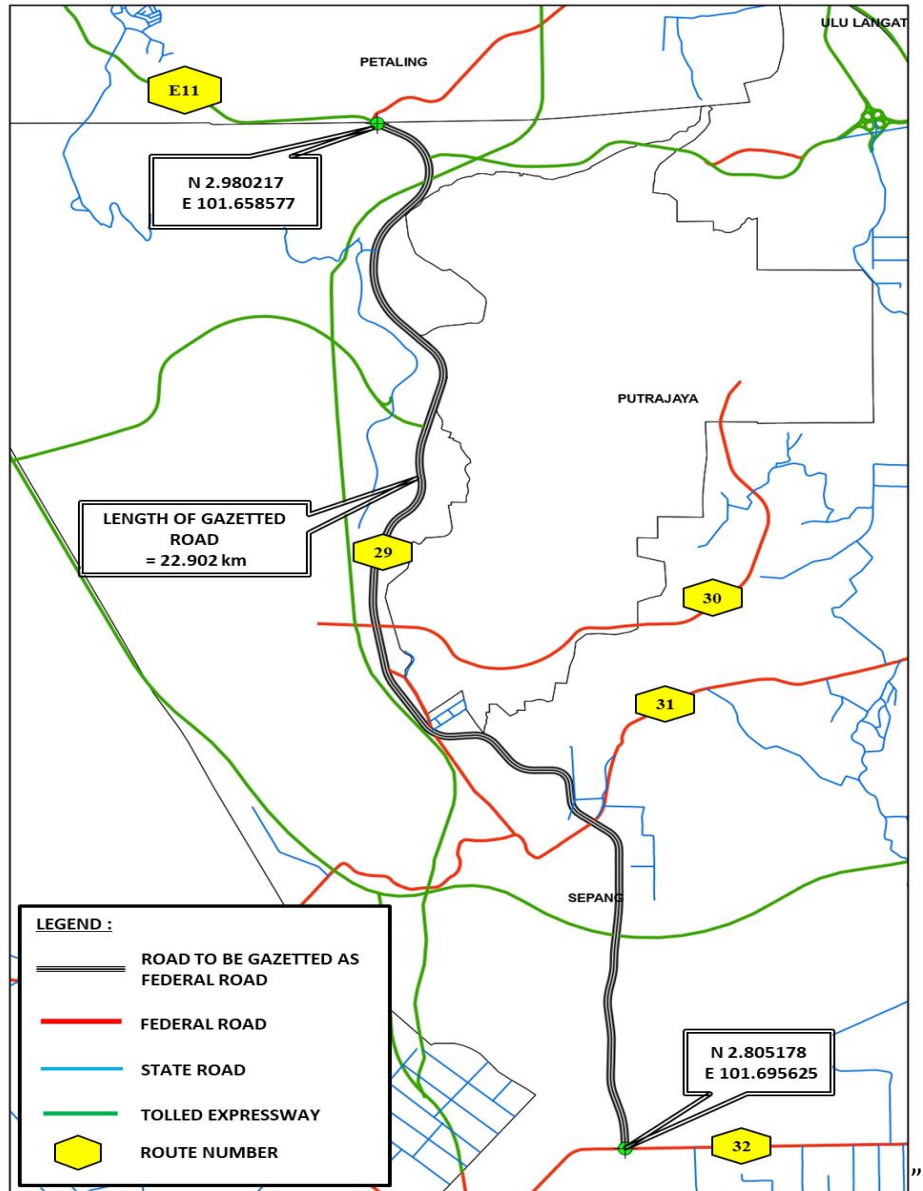
“37. (*Route 29*): *Puchong–Kota Warisan*

Starting from the end of the Damansara Puchong–Putrajaya and Cyberjaya Highway at coordinates N 2.980217, E 101.658577 and ending at the junction of Route 32, Labohan Dagang–Nilai Road at coordinates N 2.805178, E 101.695625 including its link roads within the boundaries of right of way as shown on MAP 13: PUCHONG–KOTA WARISAN (a distance of 22.902 km).”;

(b) by deleting item 50; and

(c) by substituting for MAP 13: SELANGOR DARUL EHSAN STATE FEDERAL ROADS the following map:
