## AKTA AKAUNTAN 1967

## PERINTAH AKAUNTAN (PINDAAN JADUAL PERTAMA) (NO. 2) 2024

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(7) dan subseksyen 15A(3) Akta Akauntan 1967 [*Akta 94*], Menteri, selepas meminta nasihat Institut Akauntan Malaysia, membuat perintah yang berikut:

**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Akauntan (Pindaan Jadual Pertama) (No. 2) 2024**.

**Pindaan Jadual Pertama**

2. Jadual Pertama kepada Akta dipinda—

(a) dalam Bahagian I—

(i) dalam perenggan (*n*), dengan menggantikan perkataan “Kolej Universiti Sains dan Teknologi Malaysia” dengan perkataan “Universiti Malaysia Terengganu”; dan

(ii) dalam perenggan (*p*), dengan menggantikan perkataan “Universiti Industri Selangor” dengan perkataan “Universiti Selangor”; dan

(b) dalam Bahagian II—

(i) dengan memotong perenggan (*f*);

(ii) dalam perenggan (*g*), dengan menggantikan perkataan “Australian Society of Certified Practising Accountants” dengan perkataan “CPA Australia”;

(iii) dengan memotong perenggan (*h*);

- (iv) dalam perenggan (j), dengan memotong perkataan “and” di hujung perenggan itu;
- (v) dalam perenggan (k), dengan menggantikan noktah di hujung perenggan itu dengan koma bertindih; dan
- (vi) dengan memasukkan selepas perenggan (k) perenggan yang berikut:

“(l) Chartered Accountants Australia and New Zealand.”.

ACCOUNTANTS ACT 1967

ACCOUNTANTS (AMENDMENT OF FIRST SCHEDULE) (NO. 2) ORDER 2024

IN exercise of the powers conferred by subsection 14(7) and subsection 15A(3) of the Accountants Act 1967 [Act 94], the Minister, after seeking the advice of the Malaysian Institute of Accountants, makes the following order:

**Citation**

1. This order may be cited as the **Accountants (Amendment of First Schedule) (No. 2) Order 2024**.

**Amendment of First Schedule**

2. The First Schedule to the Act is amended—

(a) in Part I—

- (i) in paragraph (n), by substituting for the words “Kolej Universiti Sains dan Teknologi Malaysia” the words “Universiti Malaysia Terengganu”; and
- (ii) in paragraph (p), by substituting for the words “Universiti Industri Selangor” the words “Universiti Selangor”; and

(b) in Part II—

- (i) by deleting paragraph (f);
- (ii) in paragraph (g), by substituting for the words “Australian Society of Certified Practising Accountants” the words “CPA Australia”; and
- (iii) by deleting paragraph (h);

- (iv) in paragraph *(j)*, by deleting the word “and” at the end of that paragraph;
- (v) in paragraph *(k)*, by substituting for the full stop at the end of that paragraph a semicolon; and
- (vi) by inserting after paragraph *(k)* the following paragraph:

“(l) Chartered Accountants Australia and New Zealand.”.
