AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (SARAWAK) (PINDAAN) (NO. 4) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Sarawak, membuat perintah yang berikut:

**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Sarawak) (Pindaan) (No. 4) 2024**.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Sarawak) 1996 [P.U. (A) 551/1996], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama, di bawah kepala LEBUH RAYA PAN BORNEO, dengan memasukkan selepas butiran (jl) butiran yang berikut:

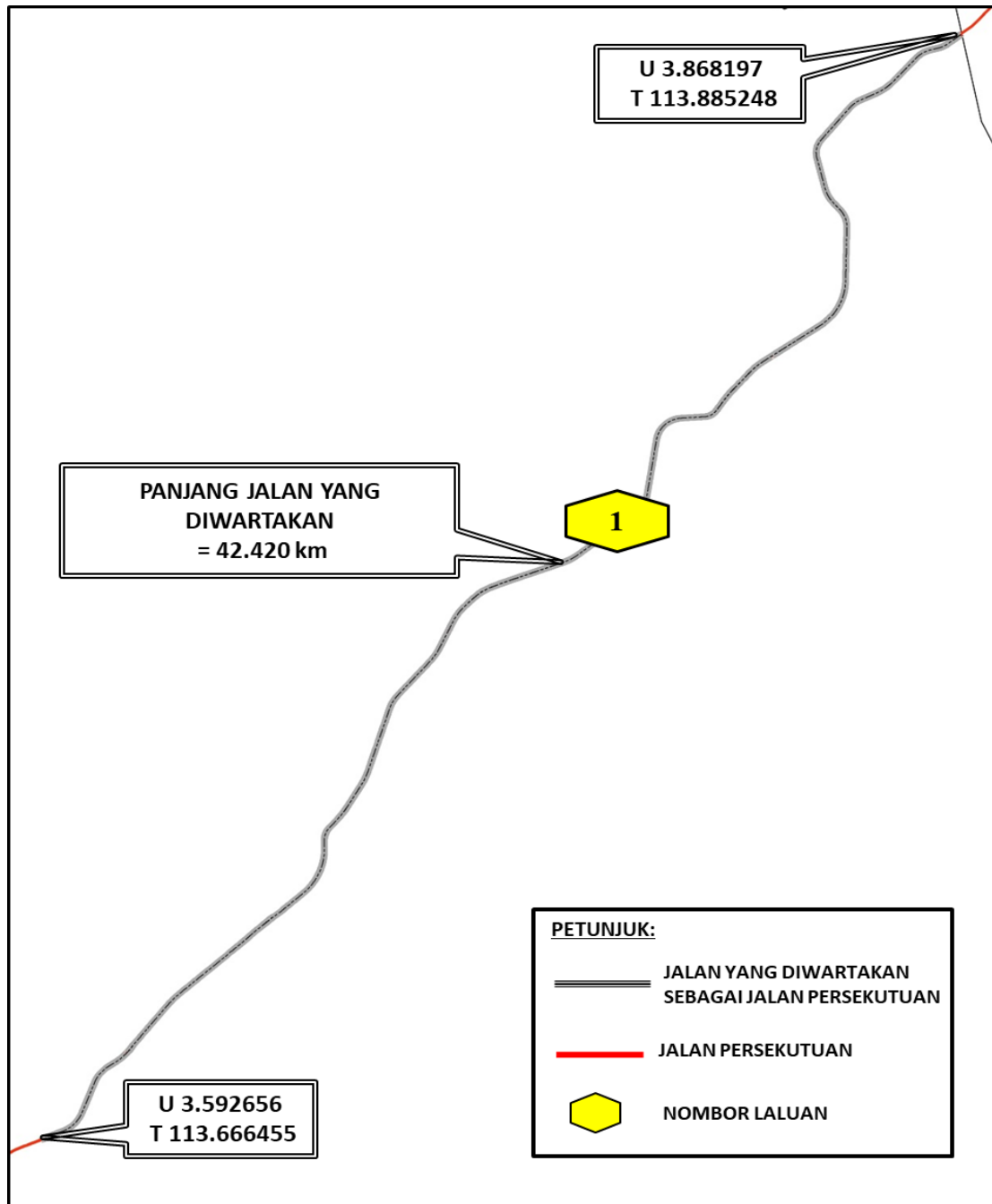
“(jm) (Laluan 1): Ladang Alam Bumi–Simpang Ladang Tiga

Bermula di koordinat U 3.592656, T 113.666455 dan berakhir di koordinat U 3.868197, T 113.885248 termasuk jalan sambungannya di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA LADANG ALAM BUMI–SIMPANG LADANG TIGA (jarak sepanjang 42.420 km).”.

**Pindaan Jadual Ketiga**

3. Perintah ibu dipinda dalam Jadual Ketiga dengan memasukkan selepas PETA SEMATAN-JAMBATAN SUNGAI KAYAN ULU peta yang berikut:

“PETA LADANG ALAM BUMI–SIMPANG LADANG TIGA

FEDERAL ROADS ACT 1959

FEDERAL ROADS (SARAWAK) (AMENDMENT) (NO. 4) ORDER 2024

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Sarawak, makes the following order:

**Citation**

1. This order may be cited as the **Federal Roads (Sarawak) (Amendment) (No. 4) Order 2024**.

**Amendment of First Schedule**

2. The Federal Roads (Sarawak) Order 1996 [*P.U. (A) 551/1996*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule, under the heading PAN BORNEO HIGHWAY, by inserting after item *(j)* the following item:

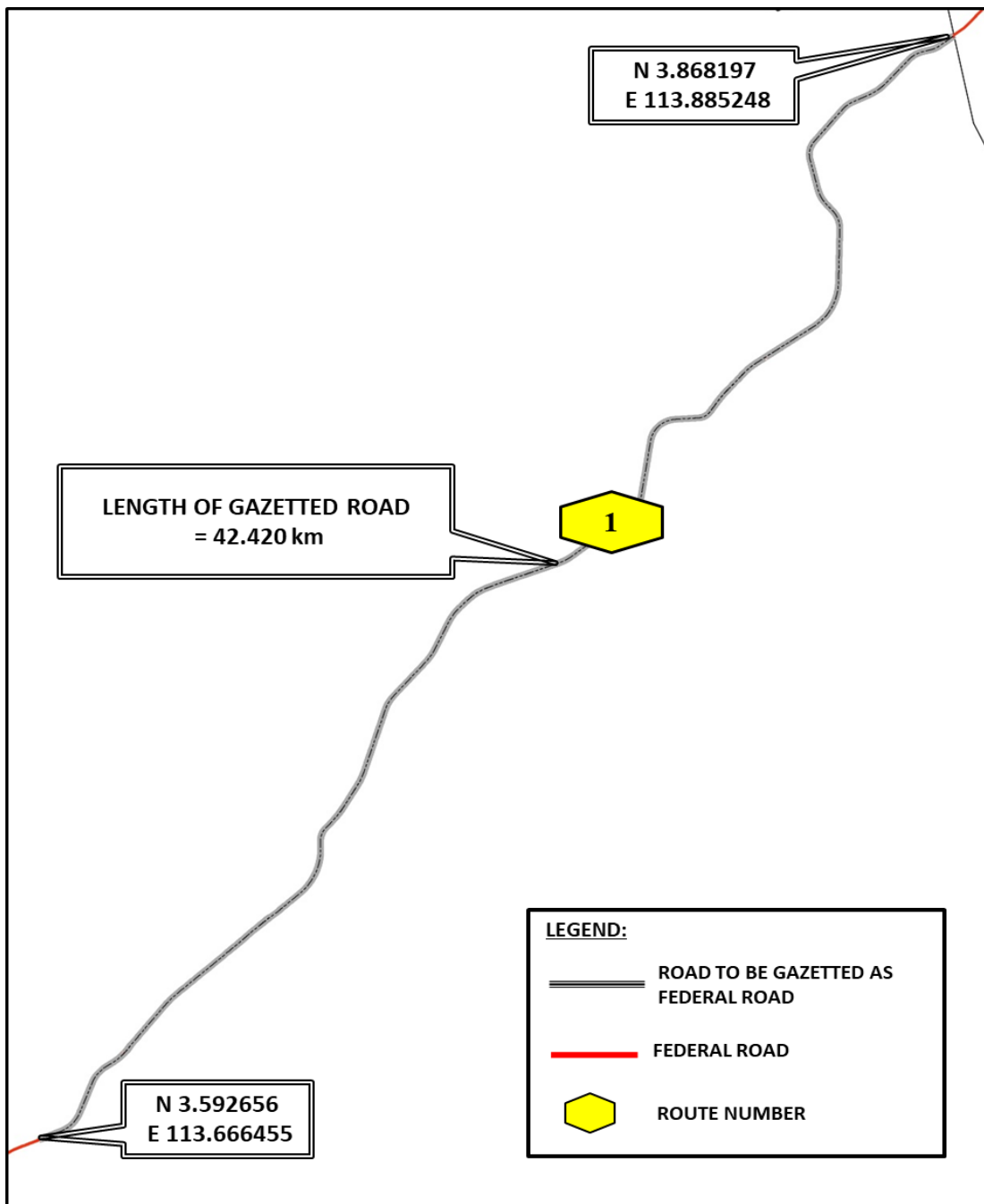
*“(jm) (Route 1): Alam Bumi Farm–Ladang Tiga Junction*

Starting at coordinates N 3.592656, E 113.666455 and ending at coordinates N 3.868197, E 113.885248 including its link road within the boundaries of right of way as shown on MAP OF ALAM BUMI FARM–LADANG TIGA JUNCTION (a distance of 42.420 km).”.

**Amendment of Third Schedule**

3. The principal Order is amended in the Third Schedule by inserting after MAP OF SEMATAN-SUNGAI KAYAN ULU BRIDGE the following map:
