AKTA FUNGSI-FUNGSI MENTERI 1969

PERINTAH MENTERI-MENTERI KERAJAAN PERSEKUTUAN (PINDAAN) (NO. 4) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Fungsi-Fungsi Menteri 1969 [*Akta 2*], Yang di-Pertuan Agong membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Menteri-Menteri Kerajaan Persekutuan (Pindaan) (No. 4) 2024**.

(2) Subsubperenggan 2(a)(i) dan subperenggan 2(c) disifatkan telah mula berkuat kuasa pada 12 Disember 2023.

(3) Subsubperenggan 2(a)(ii) disifatkan telah mula berkuat kuasa pada 1 Januari 2024.

(4) Subsubperenggan 2(a)(iii) disifatkan telah mula berkuat kuasa pada 3 Disember 2022.

(5) Subperenggan 2(b) disifatkan telah mula berkuat kuasa pada 7 Februari 2024.

**Pindaan Jadual**

2. Perintah Menteri-Menteri Kerajaan Persekutuan 2023 [*P.U. (A) 27/2023*] dipinda dalam Jadual—

  - (ii) dengan menggantikan perkataan “Timbalan Menteri Peralihan Tenaga dan Daya Guna Awam” dalam ruang “Gelaran dan Nama Jawatan/Tarikh Pelantikan” dengan perkataan “Timbalan Menteri Peralihan Tenaga dan Transformasi Air”; dan
  - (iii) dengan menggantikan perkataan “Kementerian Peralihan Tenaga dan Daya Guna Awam” dalam ruang “Jabatan/Perkara” dengan perkataan “Kementerian Peralihan Tenaga dan Transformasi Air”; dan
- (c) berkenaan dengan Kementerian Digital, dengan menggantikan butiran “Unit Pemodenan Tadbiran dan Perancangan Pengurusan Malaysia (MAMPU)” dalam ruang “Jabatan/Perkara” dengan butiran “Jabatan Digital Negara (JDN)”.

MINISTERIAL FUNCTIONS ACT 1969

MINISTERS OF THE FEDERAL GOVERNMENT (AMENDMENT) (NO. 4) ORDER 2024

IN exercise of the powers conferred by section 2 of the Ministerial Functions Act 1969 [Act 2], the Yang di-Pertuan Agong makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Ministers of the Federal Government (Amendment) (No. 4) Order 2024**.

(2) Subsubparagraph 2(a)(i) and subparagraph 2(c) are deemed to have come into operation on 12 December 2023.

(3) Subsubparagraph 2(a)(ii) is deemed to have come into operation on 1 January 2024.

(4) Subsubparagraph 2(a)(iii) is deemed to have come into operation on 3 December 2022.

(5) Subparagraph 2(b) is deemed to have come into operation on 7 February 2024.

**Amendment of Schedule**

2. The Ministers of the Federal Government Order 2023 [P.U. (A) 27/2023] is amended in the Schedule—

(a) in respect of the Prime Minister's Department—

(i) by deleting the item "National Academy" in the "Department/Subject" column;

- (ii) by inserting after the item “Federal Territory of Labuan Native Court” in the “Department/Subject” column the item “National Academy”; and
  - (iii) by inserting after the item “Adoption Ordinance 1960 [Sabah No. 23/1960]” in the “Department/Subject” column the item “Syarie Legal Profession (Federal Territories) Act 2019 [Act 814]”;
- (b) in respect of the Ministry of Energy Transition and Public Utilities—
- (i) by substituting for the words “Minister of Energy Transition and Public Utilities” in the “Style and Title/Date of Appointment” column the words “Minister of Energy Transition and Water Transformation”;
  - (ii) by substituting for the words “Deputy Minister of Energy Transition and Public Utilities” in the “Style and Title/Date of Appointment” column the words “Deputy Minister of Energy Transition and Water Transformation”; and
  - (iii) by substituting for the words “Ministry of Energy Transition and Public Utilities” in the “Department/Subject” column the words “Ministry of Energy Transition and Water Transformation”; and
- (c) in respect of the Ministry of Digital, by substituting for the item “Malaysian Administrative Modernisation and Management Planning Unit (MAMPU)” in the “Department/Subject” column the item “National Digital Department”.
