PERINTAH HAD LAJU KEBANGSAAN (PEMBERHENTIAN SEMENTARA) (NO. 2) 2024

(2) Perintah ini berkuat kuasa mulai 8 April 2024 hingga 14 April 2024.

2. Subperenggan 2(1) Perintah Had Laju Kebangsaan 1989 [*P.U. (A) 18/1989*] hendaklah terhenti berkuat kuasa.

ROAD TRANSPORT ACT 1987

NATIONAL SPEED LIMIT (TEMPORARY CESSATION) (NO. 2) ORDER 2024

IN exercise of the powers conferred by subsection 69(1) of the Road Transport Act [Act 333], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **National Speed Limit (Temporary Cessation) (No. 2) Order 2024**.

(2) This Order has effect from 8 April 2024 to 14 April 2024.

**Temporary cessation**

2. Subparagraph 2(1) of the National Speed Limit Order 1989 [P.U. (A) 18/1989] shall cease to have effect.
