AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (SARAWAK) (PINDAAN) (NO. 3) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Sarawak, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Sarawak) (Pindaan) (No. 3) 2024**.

(2) Perintah ini mula berkuat kuasa pada 8 Mac 2024.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Sarawak) 1996 [P.U. (A) 551/1996], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama, di bawah kepala LEBUH RAYA PAN BORNEO, dengan memasukkan selepas butiran (jk) butiran yang berikut:

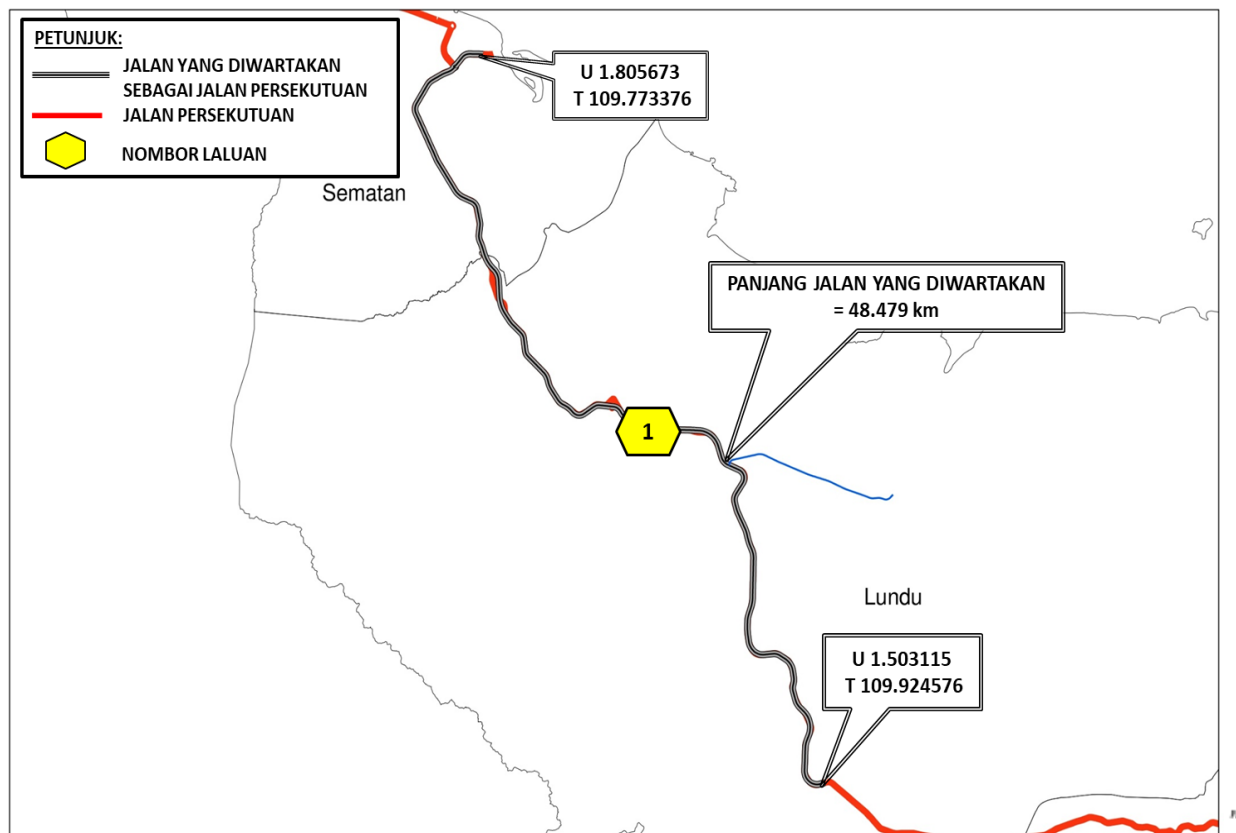
“ (jl) (Laluan 1): Sematan-Jambatan Sungai Kayan Ulu

Bermula di koordinat U 1.805673, T 109.773376 dan berakhir di koordinat U 1.503115, T 109.924576 termasuk jalan sambungannya di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA SEMATAN-JAMBATAN SUNGAI KAYAN ULU (jarak sepanjang 48.479 km).”.

**Pindaan Jadual Ketiga**

3. Perintah ibu dipinda dalam Jadual Ketiga dengan memasukkan selepas PETA JAMBATAN SUNGAI ENTULANG-BATANG SKRANG peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (SARAWAK) (AMENDMENT) (NO. 3) ORDER 2024

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Sarawak, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Sarawak) (Amendment) (No. 3) Order 2024**.

(2) This Order comes into operation on 8 March 2024.

**Amendment of First Schedule**

2. The Federal Roads (Sarawak) Order 1996 [*P.U. (A) 551/1996*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule, under the heading of PAN BORNEO HIGHWAY, by inserting after item (*jk*) the following item:

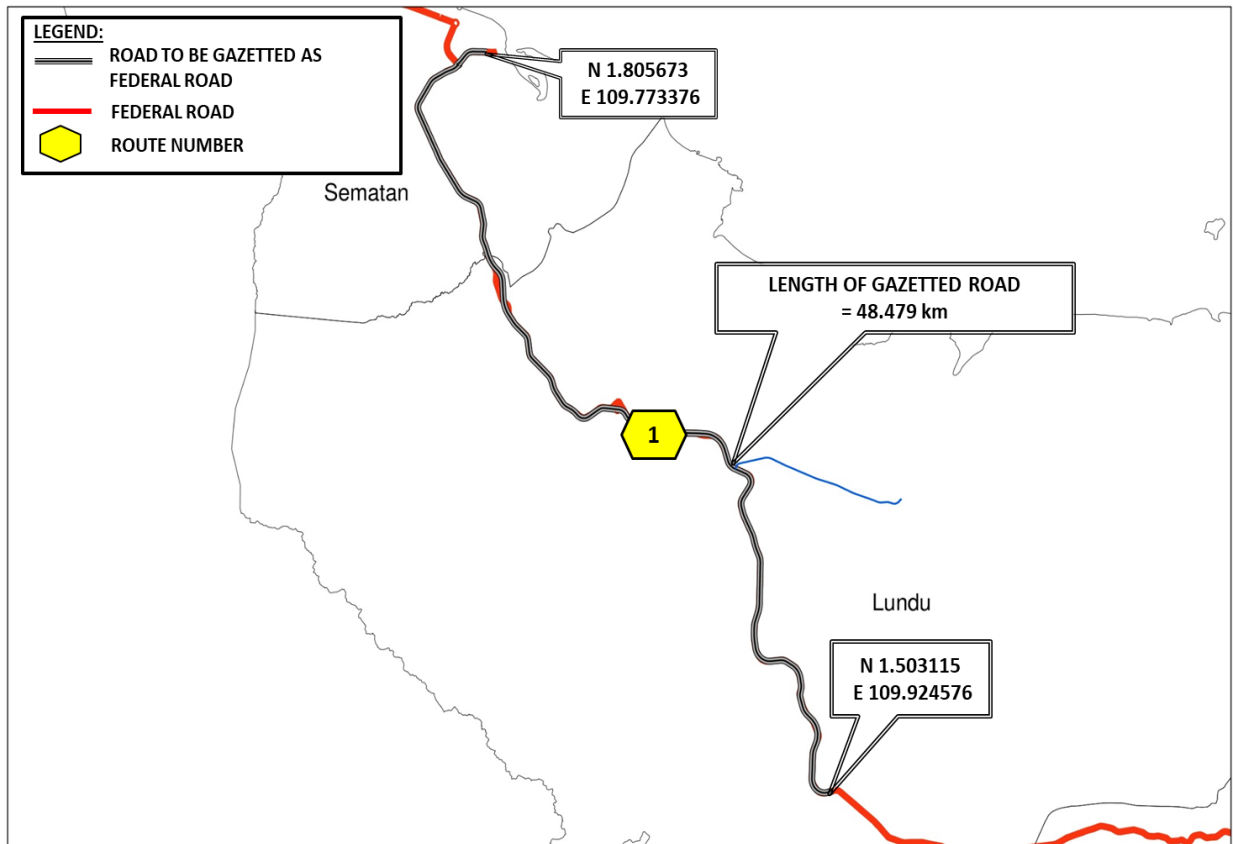
*“(jl) (Route 1): Sematan-Sungai Kayan Ulu Bridge*

Starting at coordinates N 1.805673, E 109.773376 and ending at coordinates N 1.503115, E 109.924576 including its link road within the boundaries of right of way as shown on MAP OF SEMATAN-SUNGAI KAYAN ULU BRIDGE (a distance of 48.479 km).”.

**Amendment of Third Schedule**

3. The principal Order is amended in the Third Schedule by inserting after MAP OF SUNGAI ENTULANG BRIDGE-BATANG SKRANG the following map:
