AKTA PROFESION UNDANG-UNDANG 1976

KAEDAH-KAEDAH SARAAN PEGUAM CARA (PENGUATKUASAAN) (PINDAAN) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 77 Akta Profesion Undang-Undang 1976 [*Akta 166*], Majlis Peguam, dengan kelulusan Peguam Negara, membuat kaedah-kaedah yang berikut:

**Nama**

1. Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Saraan Peguam Cara (Penguatkuasaan) (Pindaan) 2024**.

**Pindaan am**

2. Kaedah-Kaedah Saraan Peguam Cara (Penguatkuasaan) 2016 [*P.U. (A) 340/2016*], yang disebut “Kaedah-Kaedah ibu” dalam Kaedah-Kaedah ini, dipinda—

(a) dalam teks bahasa kebangsaan, dengan menggantikan perkataan “*Bar Malaysia*” di mana-mana jua terdapat dengan perkataan “Badan Peguam Malaysia”; dan

(b) dengan menggantikan perkataan “Majlis Peguam Malaysia, No. 15 Leboh Pasar Besar, 50050 Kuala Lumpur” di mana-mana jua terdapat dengan perkataan “Majlis Peguam, Wisma Badan Peguam Malaysia, No. 2 Leboh Pasar Besar, 50050 Kuala Lumpur”.

**Pindaan kaedah 2**

3. Kaedah 2 Kaedah-Kaedah ibu dipinda—

(a) dalam takrif “urusan bukan bertikaian”, dengan menggantikan perkataan “Perintah Saraan Peguam Cara 2005 [*P.U. (A) 520/2005*]” dengan perkataan “Perintah Saraan Peguam Cara 2023 [*P.U. (A) 207/2023*]”; dan

- (b) dalam takrif “skala atau fi tetap”, dengan menggantikan perkataan “Perintah Saraan Peguam Cara 2005” dengan perkataan “Perintah Saraan Peguam Cara 2023”.

### **Pindaan kaedah 3**

4. Kaedah 3 Kaedah-Kaedah ibu dipinda dengan menggantikan subkaedah (2) dengan subkaedah yang berikut:

“(2) Tanda “tiada diskaun” hendaklah mengandungi perkataan yang berikut:

“Tiada diskaun ke atas fi yang dinyatakan dalam Susunan B Jadual Pertama, Jadual Kedua, Susunan B Jadual Ketiga, Jadual Keempat, Jadual Kelima dan Jadual Keenam kepada Perintah Saraan Peguam Cara 2023 [*P.U. (A) 207/2023*]”.

### **Pindaan Jadual**

5. Kaedah-Kaedah ibu dipinda dalam Jadual—

(a) dalam Borang A—

- (i) dalam tajuk, dengan menggantikan perkataan “PERINTAH SARAAN PEGUAM CARA 2005” dengan perkataan “PERINTAH SARAAN PEGUAM CARA 2023”; dan
- (ii) dengan menggantikan perkataan “Majlis Peguam Malaysia” dengan perkataan “Majlis Peguam”;

(b) dalam Borang B, dalam perenggan 1, dengan menggantikan perkataan “Borang B” dengan perkataan “Borang C”; dan

- (c) dalam Borang C—
- (i) dengan menggantikan perkataan “Borang A” di mana-mana jua terdapat dengan perkataan “Borang B”; dan
  - (ii) dalam ruang no. (3) ARAHAN BAGI PENYEMPURNAAN PENYATA DAN JENIS DOKUMEN UNTUK DILAMPIRKAN BERSAMA DENGAN PENYATA, dalam butiran yang keempat, dengan menggantikan perkataan “Borang 34” dengan perkataan “pendaftaran gadaian di bawah seksyen 352, 354 dan 356 Akta Syarikat 2016 [Akta 777]”.

## LEGAL PROFESSION ACT 1976

## SOLICITORS' REMUNERATION (ENFORCEMENT) (AMENDMENT) RULES 2024

IN exercise of the powers conferred by section 77 of the Legal Profession Act 1976 [Act 166], the Bar Council, with the approval of the Attorney General, makes the following rules:

**Citation**

1. These rules may be cited as the **Solicitors' Remuneration (Enforcement) (Amendment) Rules 2024**.

**General amendment**

2. The Solicitors' Remuneration (Enforcement) Rules 2016 [P.U. (A) 340/2016], which are referred to as the "principal Rules" in these Rules, are amended—

(a) in the national language text, by substituting for the words "*Bar Malaysia*" wherever appearing the words "*Badan Peguam Malaysia*"; and

(b) by substituting for the words "*Bar Council Malaysia, No. 15 Leboh Pasar Besar, 50050 Kuala Lumpur*" wherever appearing the words "*Bar Council, Wisma Badan Peguam Malaysia, No. 2 Leboh Pasar Besar, 50050 Kuala Lumpur*".

**Amendment of rule 2**

3. Rule 2 of the principal Rules is amended—

(a) in the definition of "non-contentious business", by substituting for the words "*Solicitors' Remuneration Order 2005 [P.U. (A) 520/2005]*" the words "*Solicitors' Remuneration Order 2023 [P.U. (A) 207/2023]*"; and

(b) in the definition of "scale or fixed fee", by substituting for the words "*Solicitors' Remuneration Order 2005*" the words "*Solicitors' Remuneration Order 2023*".

**Amendment of rule 3**

4. Rule 3 of the principal Rules is amended by substituting for subrule (2) the following subrule:

“(2) The “no discount” signage shall contain the following words:

“There shall be no discount on the fee specified in Table B of the First Schedule, the Second Schedule, Table B of the Third Schedule, the Fourth Schedule, the Fifth Schedule and the Sixth Schedule to the Solicitors’ Remuneration Order 2023 [*P.U. (A) 207/2023*]”.

**Amendment of Schedule**

5. The principal Rules are amended in the Schedule—

(a) in Form A—

(i) in the title, by substituting for the words “SOLICITORS’ REMUNERATION ORDER 2005” the words “SOLICITORS’ REMUNERATION ORDER 2023”; and

(ii) by substituting for the words “Bar Council Malaysia” the words “Bar Council”;

(b) in Form B, in paragraph 1, by substituting for the words “Form B” the words “Form C”; and

(c) in Form C—

(i) by substituting for the words “Form A” wherever appearing the words “Form B”; and

- (ii) in column no. (3) of INSTRUCTIONS FOR COMPLETION OF THE RETURN AND TYPE OF DOCUMENTS TO BE ENCLOSED WITH THE RETURN, in the fourth item, by substituting for the words “Form 34” the words “registration of charges under sections 352, 354 and 356 of the Companies Act 2016 [Act 777]”.
