WATER SERVICES INDUSTRY ACT 2006

WATER SERVICES INDUSTRY (RATES FOR WATER SUPPLY SERVICES)  
(STATE OF KELANTAN) (AMENDMENT) REGULATIONS 2024

IN exercise of the powers conferred by paragraphs 84(2)(a) and 179(i) of the Water Services Industry Act 2006 [*Act 655*], the Minister, on the recommendation of the Commission, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Water Services Industry (Rates for Water Supply Services) (State of Kelantan) (Amendment) Regulations 2024**.

(2) These Regulations come into operation on 1 February 2024.

**Substitution of First Schedule**

2. The Water Services Industry (Rates for Water Supply Services) (State of Kelantan) Regulations 2010 [*P.U. (A) 333/2010*] are amended by substituting for the First Schedule the following schedule:
