MINISTERIAL FUNCTIONS ACT 1969

MINISTERS OF THE FEDERAL GOVERNMENT (AMENDMENT) (NO. 3) ORDER 2024

IN exercise of the powers conferred by section 2 of the Ministerial Functions Act 1969 [Act 2], the Yang di-Pertuan Agong makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Ministers of the Federal Government (Amendment) (No. 3) Order 2024**.

(2) This Order is deemed to have come into operation on 12 December 2023.

Amendment of Schedule

2. The Ministers of the Federal Government Order 2023 [P.U. (A) 27/2023] is amended in the Schedule—

(a) in respect of the Prime Minister's Department—

- (i) by deleting the item “CyberSecurity Malaysia” in the “Department/Subject” column;
- (ii) by deleting the item “MIMOS Berhad” in the “Department/Subject” column;
- (iii) by deleting the item “The Federal Territories Director of Lands and Mines Office (PPTGWP)” in the “Department/Subject” column; and
- (iv) by inserting after the item “Kuala Lumpur City Hall” in the “Department/Subject” column the item “The Federal Territories Director of Lands and Mines Office (PPTGWP)”;

- (b) in respect of the Ministry of Energy Transition and Public Utilities, by deleting the item “Malaysian Green Technology and Climate Change Centre (MGTC)” in the “Department/Subject” column;
- (c) in respect of the Ministry of Economy, by deleting the item “MyDIGITAL Corporation” in the “Department/Subject” column;
- (d) in respect of the Ministry of Science, Technology and Innovation, by inserting after the item “Malaysian Bioeconomy Development Corporation Sdn. Bhd. (Bioeconomy Corp.)” in the “Department/Subject” column the item “MIMOS Berhad”;
- (e) in respect of the Ministry of Domestic Trade and Cost of Living, by deleting the item “Franchise Act 1998 [Act 590]” in the “Department/Subject” column;
- (f) in respect of the Ministry of Natural Resources and Environmental Sustainability, by inserting after the item “Yayasan Hijau Malaysia (YaHijau)” in the “Department/Subject” column the following items:
- “Malaysian Green Technology
and Climate Change Corporation
(MGTC)
- Malaysia Forest Fund (MFF)”;
- (g) in respect of the Ministry of Entrepreneur and Cooperatives Development, by inserting after the item “Perbadanan Pembangunan Bandar (Dissolution) Act 1996 [Act 547]” in the “Department/Subject” column the item “Franchise Act 1998 [Act 590]”; and

(h) in respect of the Ministry of Digital, by inserting after the item “Digital Nasional Berhad (DNB)” in the “Department/Subject” column the following items:

“CyberSecurity Malaysia

MyDIGITAL Corporation”.
