ENERGY COMMISSION (SUSPENSION OF OPERATION OF THE ACT FOR SABAH)
(NO. 2) ORDER 2023

IN exercise of the powers conferred by subsection 1(4) of the Energy Commission Act 2001 [*Act 610*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Energy Commission (Suspension of Operation of the Act for Sabah) (No. 2) Order 2023**.

(2) This Order comes into operation on 3 January 2024.

Suspension of operation of Act

2. The Minister suspends the operation of the whole Act for Sabah.
