PADA menjalankan kuasa yang diberikan oleh subseksyen 2(2) Akta Pemajuan Perumahan (Kawalan dan Pelesenan) 1966 [*Akta 118*], Menteri membuat perintah yang berikut:

**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Pemajuan Perumahan (Kawalan dan Pelesenan) (Pengecualian) 2023**.

**Pengecualian**

2. Menteri mengecualikan pemaju perumahan yang dinyatakan dalam ruang (1) Jadual yang merupakan pemegang lesen pemajuan perumahan yang dinyatakan dalam ruang (2) Jadual daripada pemakaian peruntukan kontrak seragam bagi jualan dan belian di bawah peraturan 11 Peraturan-Peraturan Pemajuan Perumahan (Kawalan dan Pelesenan) 1989 [*P.U. (A) 58/1989*] sebagaimana yang diperihalkan dalam fasal kontrak seragam yang dinyatakan dalam ruang (3) Jadual mulai tarikh yang dinyatakan dalam ruang (4) Jadual.

HOUSING DEVELOPMENT (CONTROL AND LICENSING) ACT 1966

HOUSING DEVELOPMENT (CONTROL AND LICENSING)  
(EXEMPTION) ORDER 2023

IN exercise of the powers conferred by subsection 2(2) of the Housing Development (Control and Licensing) Act 1966 [*Act 118*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Housing Development (Control and Licensing) (Exemption) Order 2023**.

**Exemption**

2. The Minister exempts the housing developer specified in column (1) of the Schedule being the holder of the housing development licence specified in column (2) of the Schedule from the application of provisions of uniform contract for sale and purchase under regulation 11 of the Housing Development (Control and Licensing) Regulations 1989 [*P.U. (A) 58/1989*] as described in the clause of uniform contract specified in column (3) of the Schedule from the date specified in column (4) of the Schedule.
