(2) Perintah ini mula berkuat kuasa pada 20 Oktober 2023.

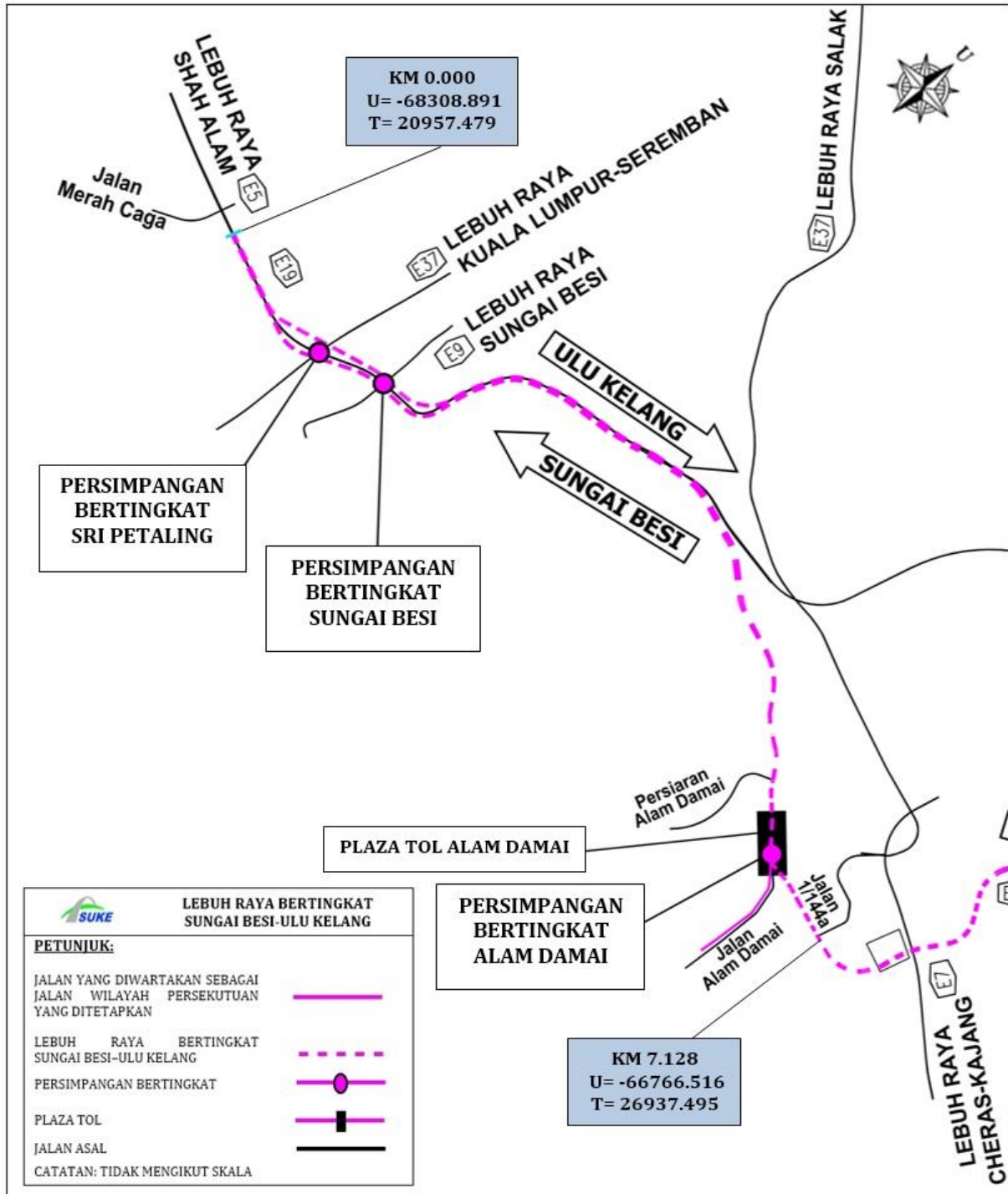

ORDER 2023

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Sungai Besi-Ulu Kelang Elevated Expressway) (Amendment) (No. 2) Order 2023**.

(2) This Order comes into operation on 20 October 2023.

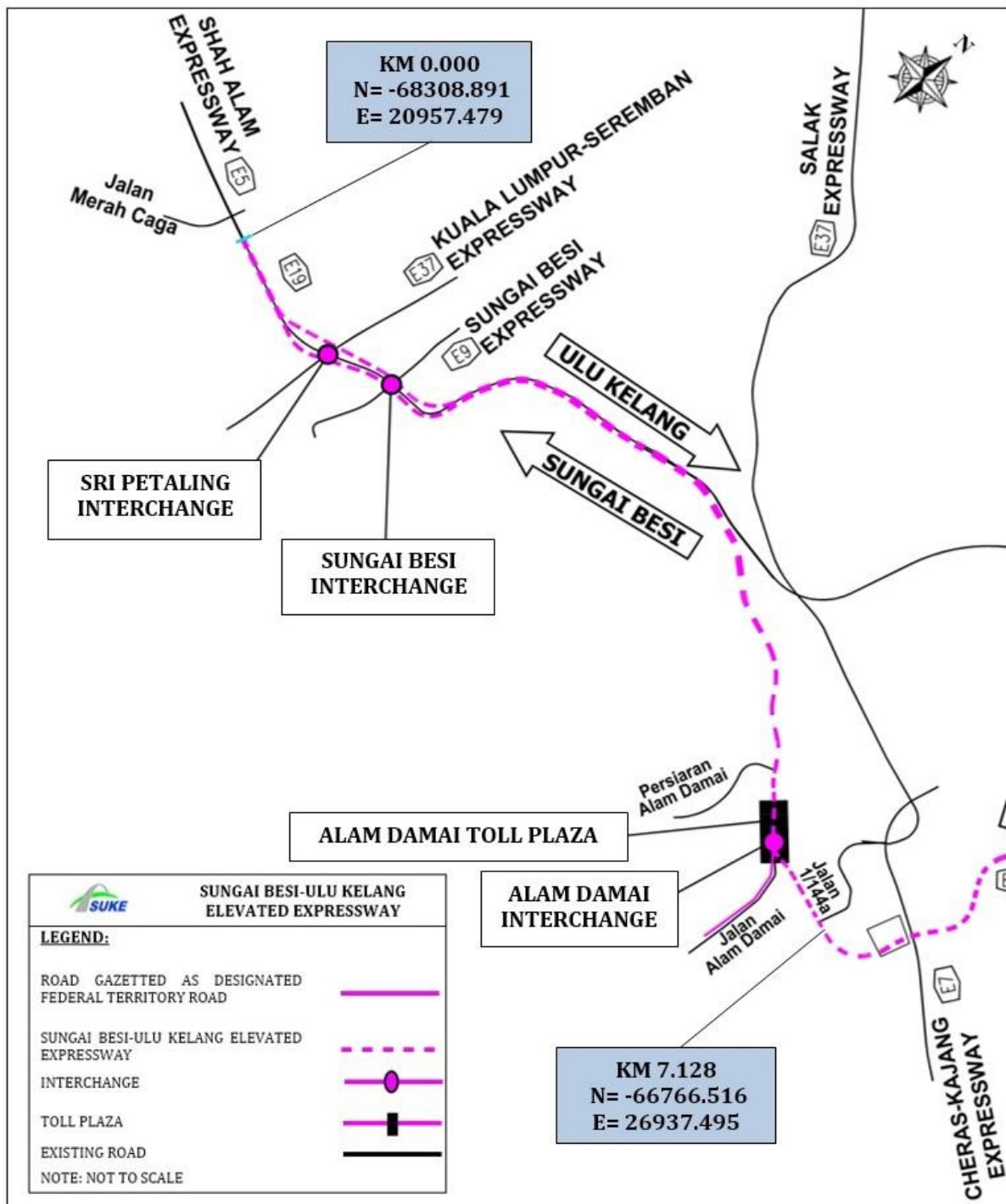
Amendment of paragraph 2

2. The Federal Roads (Private Management) (Collection of Tolls) (Sungai Besi-Ulu Kelang Elevated Expressway) Order 2022 [*P.U. (A) 333/2022*], which is referred to as the “principal Order” in this Order, is amended in subsubparagraph 2(1)(b) by inserting after the words “Alam Damai Toll Plaza” the words “, Alam Damai Interchange”.

Amendment of Second A Schedule

3. The principal Order is amended in the Second A Schedule by substituting for MAP OF SUNGAI BESI-ULU KELANG ELEVATED EXPRESSWAY the following map:
