FEDERAL TERRITORY (PLANNING) (FEE FOR PURCHASE OF LOCAL PLAN
(ALTERATION 4)) RULES 2023

IN exercise of the powers conferred by paragraph 64(2)(i) of the Federal Territory (Planning) Act 1982 [*Act 267*], the Commissioner, with the approval of the Minister, makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Federal Territory (Planning) (Fee for Purchase of Local Plan (Alteration 4)) Rules 2023**.

(2) These Rules come into operation on 23 October 2023.

2. The fee for the purchase of a copy of the Kuala Lumpur City Plan 2020 (Alteration 4) shall be as specified in the Schedule.
