REGISTRATION OF PHARMACISTS (AMENDMENT OF FIRST SCHEDULE) ORDER 2023

IN exercise of the powers conferred by subsection 6(3) of the Registration of Pharmacists Act 1951 [Act 371], the Minister, after consulting the Board, makes the following order:

**Citation**

1. This order may be cited as the **Registration of Pharmacists (Amendment of First Schedule) Order 2023**.

**Amendment of First Schedule**

2. The Registration of Pharmacists Act 1951 is amended in the First Schedule—

(a) in relation to the country of “Malaysia”, by inserting after the item “Quest International University (QIU) (formerly known as QUEST International University Perak (QIUP))” and the particulars relating to it the following item and particulars:

<i>Name of Institution granting qualification</i>	<i>Description of qualification</i>
“Universiti Sultan Zainal Abidin	Bachelor of Pharmacy (Honours) (Recognised on 27 January 2023)”; and

(b) in relation to the country of “United Kingdom”, in the item “University of Nottingham” by inserting after the existing particulars the following particulars:

<i>Name of Institution granting qualification</i>	<i>Description of qualification</i>
University of Nottingham	“Master of Pharmacy with Honours in Pharmacy (with Integrated Foundation Training) (Recognition takes effect on 1 January 2027)”.
