PERATURAN-PERATURAN SISTEM INSURANS PEKERJAAN (PERBEKALAN) 2023

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Sistem Insurans Pekerjaan (Perbekalan) 2023**.

EMPLOYMENT INSURANCE SYSTEM ACT 2017

EMPLOYMENT INSURANCE SYSTEM (SUPPLY) REGULATIONS 2023

IN exercise of the powers conferred by subsection 48(1) of the Employment Insurance System Act 2017 [Act 800], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Employment Insurance System (Supply) Regulations 2023**.

Issue for expenditure for the year 2023

2. The issue of a sum not exceeding three hundred and fifty-eight million one hundred and fifty-three thousand ringgit (RM358,153,000) from the Employment Insurance Fund for the expenditure on administration of the Employment Insurance System for the year 2023 is hereby authorized for the purposes specified in the Schedule.
