(PERBEKALAN) 2023

PADA menjalankan kuasa yang diberikan oleh subseksyen 47(1) Akta Keselamatan Sosial Pekerjaan Sendiri 2017 [*Akta 789*], Menteri membuat peraturan-peraturan yang berikut:

**Nama**

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerjaan Sendiri (Perbekalan) 2023**.

## SELF-EMPLOYMENT SOCIAL SECURITY ACT 2017

## SELF-EMPLOYMENT SOCIAL SECURITY (SUPPLY) REGULATIONS 2023

IN exercise of the powers conferred by subsection 47(1) of the Self-Employment Social Security Act 2017 [Act 789], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Self-Employment Social Security (Supply) Regulations 2023**.

**Issue for expenditure for the year 2023**

2. The issue of a sum not exceeding twenty six million sixty-six thousand ringgit (RM26,066,000) from the Self-Employment Social Security Fund for the expenditure on administration of the Self-Employment Social Security Scheme for the year 2023 is hereby authorized for the purposes specified in the Schedule.
