AKTA KESELAMATAN SOSIAL PEKERJA 1969

PERATURAN-PERATURAN KESELAMATAN SOSIAL PEKERJA (PERBEKALAN) 2023

PADA menjalankan kuasa yang diberikan oleh seksyen 72 Akta Keselamatan Sosial Pekerja 1969 [Akta 4], Menteri membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Perbekalan) 2023**.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (SUPPLY) REGULATIONS 2023

IN exercise of the powers conferred by section 72 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Employees' Social Security (Supply) Regulations 2023**.

Issue for expenditure for the year 2023

2. The issue of a sum not exceeding one billion two hundred and eighty million ninety-one thousand ringgit (RM1,280,091,000) from the Social Security Fund for the expenditure on administration of the Scheme of Social Security for the year 2023 is hereby authorized for the purposes specified in the Schedule.
