AKTA KAWALAN HARGA DAN ANTIPENCATUTAN 2011

PERINTAH KAWALAN HARGA DAN ANTIPENCATUTAN
(PENENTUAN HARGA MAKSIMUM) (NO. 12) 2023

PADA menjalankan kuasa yang diberikan oleh seksyen 4 Akta Kawalan Harga dan Antipencatutan 2011 [*Akta 723*], Pengawal, dengan kelulusan Menteri, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kawalan Harga dan Antipencatutan (Penentuan Harga Maksimum) (No. 12) 2023**.

(2) Perintah ini berkuat kuasa bagi tempoh mulai 8 Ogos 2023 hingga 7 September 2023.

2. Harga runcit maksimum bagi minyak masak kelapa sawit tulen dalam botol mengikut kuantiti yang dinyatakan dalam ruang (1) Jadual ditentukan sebagaimana yang dinyatakan dalam ruang (2).

PRICE CONTROL AND ANTI-PROFITEERING
(DETERMINATION OF MAXIMUM PRICE) (NO. 12) ORDER 2023

IN exercise of the powers conferred by section 4 of the Price Control and Anti-Profiteering Act 2011 [Act 723], the Controller, with the approval of the Minister, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Price Control and Anti-Profiteering (Determination of Maximum Price) (No. 12) Order 2023**.

(2) This Order has effect for the period from 8 August 2023 to 7 September 2023.

Maximum retail price

2. The maximum retail price for bottled pure palm cooking oil based on the quantity specified in column (1) of the Schedule is determined as in column (2).
