FEES ACT 1951

FEES (EMPLOYMENT PASS, VISIT PASS (TEMPORARY EMPLOYMENT) AND WORK PASS)
(AMENDMENT) ORDER 2023

IN exercise of the powers conferred by section 3 of the Fees Act 1951 [*Act 209*], the Yang di-Pertuan Agong makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Fees (Employment Pass, Visit Pass (Temporary Employment) and Work Pass) (Amendment) Order 2023**.

(2) This Order comes into operation on 1 August 2023.

Substitution of Schedule IB

2. The Fees (Employment Pass, Visit Pass (Temporary Employment) and Work Pass) Order 1998 [*P.U. (A) 479/1998*] is amended by substituting for the Schedule IB the following schedule:
