**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Menteri-Menteri Kerajaan Persekutuan (Pindaan) (No. 2) 2023**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 5 April 2023.

**Pindaan Jadual**

2. Perintah Menteri-Menteri Kerajaan Persekutuan 2023 [*P.U. (A) 27/2023*] dipinda dalam Jadual berkenaan dengan Kementerian Perdagangan Antarabangsa dan Industri—

(a) dengan menggantikan perkataan “Menteri Perdagangan Antarabangsa dan Industri” dalam ruang “Gelaran dan Nama Jawatan/Tarikh Pelantikan” dengan perkataan “Menteri Pelaburan, Perdagangan dan Industri”;

(b) dengan menggantikan perkataan “Timbalan Menteri Perdagangan Antarabangsa dan Industri” dalam ruang “Gelaran dan Nama Jawatan/Tarikh Pelantikan” dengan perkataan “Timbalan Menteri Pelaburan, Perdagangan dan Industri”; dan

(c) dengan menggantikan perkataan “Kementerian Perdagangan Antarabangsa dan Industri” dalam ruang “Jabatan/Perkara” dengan perkataan “Kementerian Pelaburan, Perdagangan dan Industri”.

MINISTERIAL FUNCTIONS ACT 1969

MINISTERS OF THE FEDERAL GOVERNMENT (AMENDMENT) (NO. 2) ORDER 2023

IN exercise of the powers conferred by section 2 of the Ministerial Functions Act 1969 [Act 2], the Yang di-Pertuan Agong makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Ministers of the Federal Government (Amendment) (No. 2) Order 2023**.

(2) This Order is deemed to have come into operation on 5 April 2023.

**Amendment of Schedule**

2. The Ministers of the Federal Government Order 2023 [*P.U. (A) 27/2023*] is amended in the Schedule in respect of the Ministry of International Trade and Industry—

(a) by substituting for the words “Minister of International Trade and Industry” in the “Style and Title/Date of Appointment” column the words “Minister of Investment, Trade and Industry”;

(b) by substituting for the words “Deputy Minister of International Trade and Industry” in the “Style and Title/Date of Appointment” column the words “Deputy Minister of Investment, Trade and Industry”; and

(c) by substituting for the words “Ministry of International Trade and Industry” in the “Department/Subject” column the words “Ministry of Investment, Trade and Industry”.
