(KEWAJIPAN PEMEGANG LESEN) (PINDAAN) 2023

MONEY SERVICES BUSINESS ACT 2011

MONEY SERVICES BUSINESS (DUTIES OF LICENSEES) (AMENDMENT)
REGULATIONS 2023

IN exercise of the powers conferred by subsection 78(1), paragraph 21(2)(b), subsections 26(1), 27(1), 31(1) and 36(1) of the Money Services Business Act 2011 [Act 731], the Bank, with the approval of the Minister, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Money Services Business (Duties of Licensees) (Amendment) Regulations 2023**.

(2) These Regulations are deemed to have come into operation on 1 January 2021.

Amendment of regulation 2

2. The Money Services Business (Duties of Licensees) Regulations 2012 [P.U. (A) 72/2012] is amended by deleting regulation 2.
