TRADITIONAL AND COMPLEMENTARY MEDICINE ACT 2016

TRADITIONAL AND COMPLEMENTARY MEDICINE
(DESIGNATION OF PRACTITIONER BODY) (AMENDMENT) ORDER 2023

IN exercise of the powers conferred by subsection 42(1) of the Traditional and Complementary Medicine Act 2016 [Act 775], the Minister, on the recommendation of the Council, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Traditional and Complementary Medicine (Designation of Practitioner Body) (Amendment) Order 2023**.

(2) This Order is deemed to have come into operation on 16 December 2021.

Amendment of Schedule

2. The Traditional and Complementary Medicine (Designation of Practitioner Body) Order 2020 [P.U. (A) 74/2020], is amended in the English language text, in column (1) of the Schedule, by substituting for the item “Malaysian Medical Homeopathic Council” the item “Malaysian Homeopathy Medical Council”.
