PERINTAH SURUHANJAYA PENCEGAHAN RASUAH MALAYSIA
(PENETAPAN BADAN AWAM) 2023

PADA menjalankan kuasa yang diberikan oleh subseksyen 71(1) Akta Suruhanjaya Pencegahan Rasuah Malaysia [*Akta 694*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Suruhanjaya Pencegahan Rasuah Malaysia (Penetapan Badan Awam) 2023**.

(2) Perintah ini mula berkuat kuasa pada 22 Mei 2023.

2. Mana-mana Pertubuhan Peladang yang dibentuk dan didaftarkan menurut Akta Pertubuhan Peladang 1973 [*Akta 109*] dan mana-mana Persatuan Nelayan yang ditubuhkan dan didaftarkan menurut Akta Persatuan Nelayan 1971 [*Akta 44*] ditetapkan sebagai badan awam bagi maksud Akta.

MALAYSIAN ANTI-CORRUPTION COMMISSION ACT 2009

MALAYSIAN ANTI-CORRUPTION COMMISSION
(PRESCRIPTION OF PUBLIC BODY) ORDER 2023

IN exercise of the powers conferred by subsection 71(1) of the Malaysian Anti-Corruption Commission Act [Act 694], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Malaysian Anti-Corruption Commission (Prescription of Public Body) Order 2023**.

(2) This Order comes into operation on 22 May 2023.

Prescription of public body

2. Any Farmers' Organization formed and registered pursuant to the Farmers' Organization Act 1973 [Act 109] and any Fishermen's Association formed and registered pursuant to the Fishermen's Associations Act 1971 [Act 44] are prescribed as public body for the purpose of the Act.
