PERINTAH HAD LAJU KEBANGSAAN (PEMBERHENTIAN SEMENTARA) (NO. 2) 2023

**Nama dan permulaan kuat kuasa**

(2) Perintah ini berkuat kuasa mulai 18 April 2023 hingga 27 April 2023.

2. Subperenggan 2(1) Perintah Had Laju Kebangsaan 1989 [*P.U. (A) 18/1989*] hendaklah terhenti berkuat kuasa.

ROAD TRANSPORT ACT 1987

NATIONAL SPEED LIMIT (TEMPORARY CESSATION) (NO. 2) ORDER 2023

IN exercise of the powers conferred by subsection 69(1) of the Road Transport Act 1987 [Act 333], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **National Speed Limit (Temporary Cessation) (No. 2) Order 2023**.

(2) This Order has effect from 18 April 2023 to 27 April 2023.

**Temporary cessation**

2. Subparagraph 2(1) of the National Speed Limit Order 1989 [P.U. (A) 18/1989] shall cease to have effect.
