JUDGES' REMUNERATION (AMENDMENT OF FIRST AND FIFTH SCHEDULES) REGULATIONS 2000

exercise of the powers conferred by section 19 of the Judges' Remuneration Act 1971 [Act 45], the Yang di-Pertuan Agong, after consultation with the Chief Justice, makes the following regulations:

tation and commencement

(1) These regulations may be cited as the **Judges' Remuneration (Amendment First and Fifth Schedules) Regulations 2000**.

(2) These Regulations shall be deemed to have come into operation on 1 January 2000.

New First Schedule

2. The Judges' Remuneration Act 1971, which in these Regulations are referred to as the "Act", is amended by substituting for the First Schedule the following Schedule:
