ROAD TRANSPORT ACT 1987

SPEED LIMIT (BESTARI PERDANA RAMP) (AMENDMENT) ORDER 2026

IN exercise of the powers conferred by subsection 69(2) of the Road Transport Act 1987 [*Act 333*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Speed Limit (Bestari Perdana Ramp) (Amendment) Order 2026**.

(2) This Order comes into operation on 16 August 2026.

Amendment of First Schedule

2. The Speed Limit (Bestari Perdana Ramp) Order 2026 [*P.U. (A) 29/2026*], is amended in the First Schedule, in column (1), by inserting after the words “the Bestari Perdana Ramp” the words “which is part of the Senai-Pasir Gudang-Desaru Expressway”.
