In exercise of the powers conferred by section 59(2) of the Public Utilities Act, the Public Utilities Board, with the approval of the Minister for the Environment and Water Resources, hereby makes the following Regulations:

**Citation and commencement**

1. These Regulations may be cited as the Public Utilities (Composition of Offences) Regulations 2014 and shall come into operation on 1 January 2015.

**Compoundable offences**

2. The offences under the following provisions may be compounded by the Board in accordance with section 59(1)(b) of the Act:

- (a) any offence (other than a continuing offence) under section 9(2), 19(2), 24A(1B), 26(6) or (11), 33(2)(a), 34(2), 37(1), 40(3), (6) or (10), 40G(7) or (8), 40H(2),

40O(2), 40P(2), 40Q(6), 45(7), 46(3), 47(1) or (6), 47A(1)(a), 50(1), 51, 55(3)(a) or 57(1) of the Act;
