Citation and commencement

1. This Order is the Infrastructure Protection (Protected Areas) (No. 5) Order 2025 and comes into operation on 7 April 2025.

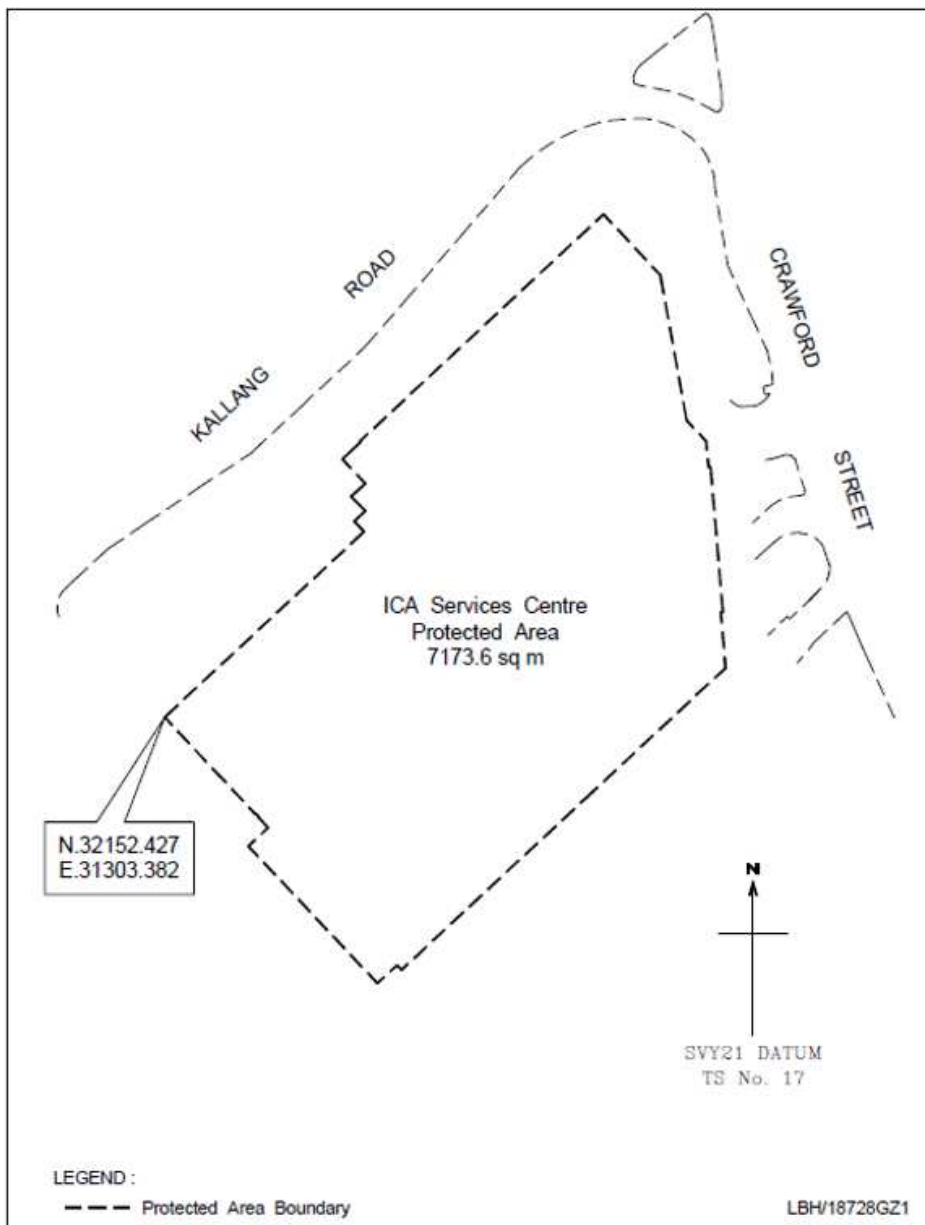
