Citation and commencement

1. This Order is the Infrastructure Protection (Protected Areas) (No. 3) Order 2026 and comes into operation on 3 July 2026.

2. The premises described in the second column of the Schedule are declared to be a protected area for the purposes of the Act, and the person specified in the first column of that Schedule is designated as the authority of the protected area.

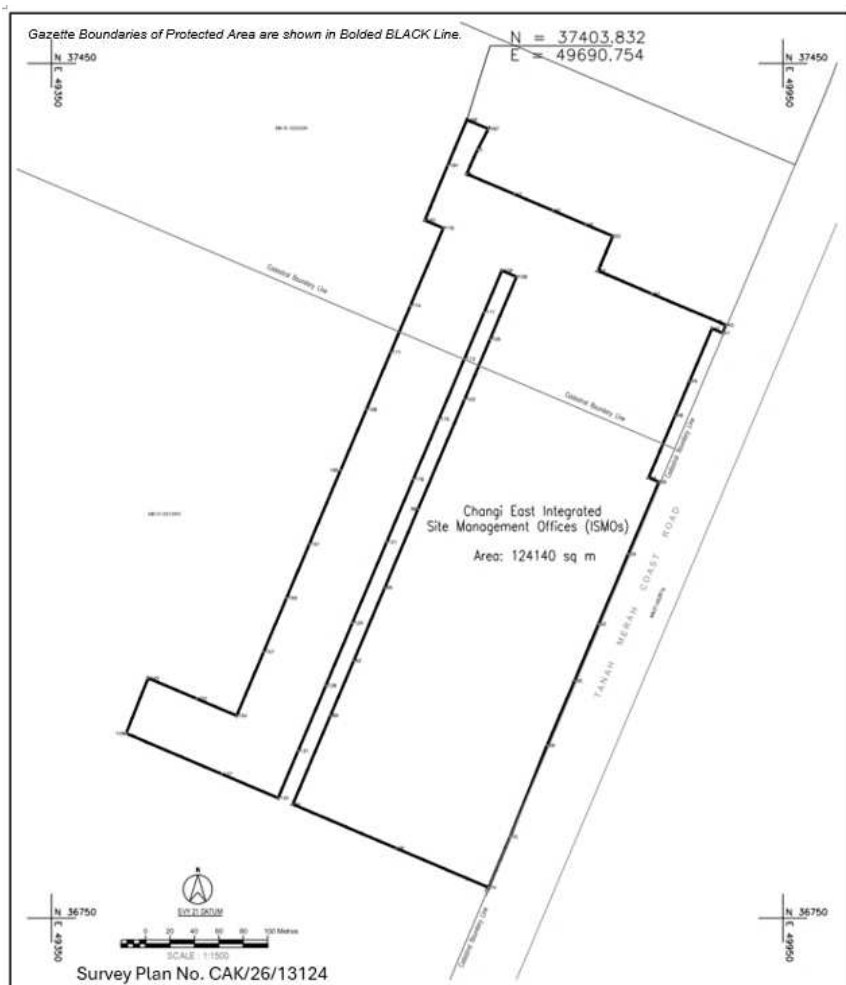
