In exercise of the powers conferred by section 56 of the Immigration Act 1959, the Minister for Home Affairs makes the following Order:

Citation and commencement

1. This Order is the Immigration (Exemption from Singapore Visa) Order 2026 and comes into operation on 1 July 2026.

Non-citizens exempt from having Singapore visa

2. The following non-citizens (other than a non-citizen who holds a valid passport from a country that is approved by the Minister under section 9B(2) of the Act) are exempt from section 9B(1) of the Act:

- (a) a permanent resident of Singapore;
- (b) any head of state of a foreign country who is a guest of the Government;
- (c) a non-citizen who holds a valid laissez-passer issued by the United Nations;
- (d) a member of any visiting force within the meaning given by section 2(1) of the Visiting Forces Act 1960;

- (e) a crew member of an aircraft that arrives in Singapore from a place outside Singapore (whether in a journey to Singapore, or in the course of a journey from a place outside Singapore to another place outside Singapore);
- (f) a non-citizen (excluding a non-citizen holding a pass that entitles him or her to enter Singapore multiple times) who holds a valid ordinary passport issued by the government of the People's Republic of China;
- (g) a non-citizen who is —
 - (i) duly accredited to Singapore as a diplomatic or consular representative of the government of the Republic of Poland, and holds a valid diplomatic passport, official passport, service passport or public affairs passport issued by the government of that country;
 - (ii) a staff member of any diplomatic or consular representative of the government of the Republic of Poland, and holds a valid diplomatic passport, official passport, service passport or public affairs passport issued by the government of that country; or
 - (iii) a spouse or dependent child of a person mentioned in sub-paragraph (i) or (ii);
- (h) a non-citizen who holds a valid passport that is issued by the government of any foreign country specified in the Schedule, the passport being of the type specified opposite that country;
- (i) a non-citizen arriving in Singapore in special circumstances where an emergency has affected the non-citizen's ability to apply for a Singapore visa.

Revocation

3. Revoke the Immigration (Exemption from Singapore Visa) Order (O 4).
