Citation and commencement

1. These Regulations are the Companies (Registers of Controllers, Nominee Directors, Nominee Shareholders, and Members of Foreign Companies) Regulations 2017 and come into operation on 31 March 2017.

5.—(1) For the purposes of section 386AF(10) of the Act, the particulars of a controller to be entered in a company's or foreign company's register of controllers are treated as confirmed if —

- (a) in response to a notice of the company or foreign company given under section 386AG(2) of the Act, a person confirms, or a registered corporate service provider confirms on behalf of the person, that the person is a registrable controller and has provided those particulars; or

- (b) a person has notified the company or foreign company under section 386AJ(1) of the Act that the person is a registrable controller and has provided those particulars.

- (a) in response to a notice of the company or foreign company given under section 386AH(1) or 386AIA(1) of the Act, the registrable controller confirms, or a registered corporate service provider confirms on behalf of the registrable controller, that a change in the registrable controller's particulars that are stated in the register of

controllers has occurred and has provided the new particulars as the particulars that have changed;

10D.—(1) For the purposes of section 386AN(6) of the Act, the Registrar may disclose any information in the central register of controllers of companies and foreign companies kept by the Registrar to —

- (a) a public agency, where —
 - (i) the public agency has requested information in the central register of controllers of companies and foreign companies; and
 - (ii) the information so requested is for the purpose of enabling the public agency to administer or enforce any written law or conduct public procurement; or
- (b) a financial institution, for the purpose of enabling the financial institution —
 - (i) to conduct customer due diligence measures to prevent money laundering and terrorism financing; or
 - (ii) to otherwise comply with any directions issued under section 16 of the Financial Services and Markets Act 2022, or any regulations made under section 192 of that Act, for the prevention of money laundering and terrorism financing.

(2) In this regulation —

“financial institution” has the meaning given by section 2 of the Financial Services and Markets Act 2022;

“public agency” has the meaning given by section 386AM(6) of the Act.

10F.—(1) For the purposes of section 386ANA(6) of the Act, the Registrar may disclose any information in the central register of nominee directors or the central register of nominee shareholders kept by the Registrar to a public agency, where —

- (a) the public agency has requested information in the central register of nominee directors or the central register of nominee shareholders; and
- (b) the information so requested has been requested for the purpose of enabling the public agency to administer or enforce any written law.

(2) For the purpose of section 386ANA(6) of the Act, the Registrar may disclose information regarding any nominee director or nominee shareholder of a company or foreign company as reflected in the central register of nominee directors or the central register of nominee shareholders, to any member of the public —

- (a) as part of a service provided to the public by the Accounting and Corporate Regulatory Authority by which information relating to transactions with the Registrar is supplied to the public, using the electronic transaction system;
- (b) as part of the implementation of Part 6A of the Accounting and Corporate Regulatory Authority Act 2004, using the electronic transaction system; or
- (c) for any other reason.

(3) In this regulation —

“electronic transaction system” means the electronic transaction system established by the Accounting and Corporate Regulatory Authority under section 27(1) of the Accounting and Corporate Regulatory Authority Act 2004;

“public agency” has the meaning given by section 386AM(6) of the Act.

Application of section 192 of Act

11.—(1) For the purposes of section 384(a)(ii) of the Act, section 192(2) and (3) of the Act applies to the register of members of a foreign company as it applies to the register of members of a public company, subject to the modifications in paragraph (2).

(2) For the purposes of paragraph (1) —

- (a) a reference in section 192(2) and (3) of the Act to “any member” is to be read as a reference to “any member of the foreign company”;
- (b) a reference in section 192(3) of the Act to “the public company” is to be read as a reference to “the foreign company”; and
- (c) a reference in section 192(3) of the Act to “the company” is to be read as a reference to “the foreign company”.

(3) Subject to the modification in paragraph (4), section 192(4) of the Act applies to a failure to send a copy of the register of members of a foreign company requested under section 192(3) of the Act as applied by paragraph (1).

(4) The modification mentioned in paragraph (3) is that —

- (a) the reference in section 192(4) of the Act to “subsection (3)” is to be read as a reference to “section 192(3) of the Act, as applied by regulation 11(1) of the Companies (Registers of Controllers, Nominee Directors, Nominee Shareholders and Members of Foreign Companies) Regulations 2017”; and
