ACTIVE MOBILITY (COMPOSITION OF OFFENCES) REGULATIONS 2018

ARRANGEMENT OF REGULATIONS

Regulation

1. Citation and commencement
 2. Compoundable offences
-

In exercise of the powers conferred by section 67 of the Active Mobility Act 2017, the Land Transport Authority of Singapore, with the approval of the Minister for Transport, makes the following Regulations:

Citation and commencement

1. These Regulations are the Active Mobility (Composition of Offences) Regulations 2018 and come into operation on 1 May 2018.

Compoundable offences

2. The following offences (other than a continuing offence) may be compounded in accordance with section 55 of the Act by the Chief Executive of the Authority, any employee of the Authority, or any public path warden authorised in writing by the Authority for the purpose of section 55 of the Act:

- (a) any offence under section 15(4), 16(4), 17(3), 18(5), 19(3), 19A(2), 20(3), 20A(3), 21(3), 22(2), 22A(2), 23(3), 23A(1), 23B(1), 23C(1), 23D(1), 23E(1), 23I(1), 23J(1), 26(6), 27(2) or (7), 28(3), 28B(3), 28G(2), 30(4), 31(2),

32(2), 33(1), 34(1), (2) or (8), 35(1), 46(5), 47(12), 48(4), 49(7) or 50(4) of the Act;
