**SOCIAL RESIDENTIAL HOMES
(EXEMPTION) ORDER 2026**

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 59 of the Social Residential Homes Act 2025, the Minister for Social and Family Development makes the following Order:

Citation and commencement

1. This Order is the Social Residential Homes (Exemption) Order 2026 and comes into operation on 1 July 2026.

Exemption for premises used to provide shared stay-in caregiving services

2.—(1) Section 6 of the Act does not apply in relation to any premises that are used by a scheme operator to provide residential accommodation to any individual under the shared stay-in caregiving services scheme.

(2) In this paragraph —

“AIC” means the company incorporated under the Companies Act 1967 as Agency for Integrated Care Pte. Ltd. (UEN 200915135W);

“scheme operator” means a person who has entered into an agreement with AIC under the shared stay-in caregiving services scheme;

“shared stay-in caregiving services” means the support of activities of daily living for a group of individuals residing at the same place;

“shared stay-in caregiving services scheme” means the scheme established by the Ministry of Health, in collaboration with the Ministry of Manpower and AIC, for the provision of shared stay-in caregiving services.

Exemption for Enabled Living Programme

3.—(1) Section 6 of the Act does not apply in relation to any premises used by a person appointed under the Enabled Living Programme to operate an adult disability home for the purposes of the Enabled Living Programme.

(2) In sub-paragraph (1), “Enabled Living Programme” means the scheme known by that name and operated by the Ministry of Social and Family Development and the Housing and Development Board, to provide residential accommodation to adults with disabilities who require minimal support and supervision.

Exemption for halfway houses

4. Section 6 of the Act does not apply in relation to any premises that are used to provide residential accommodation and biopsychosocial intervention to any individual, for the primary purpose of supporting the reintegration of the residents who are ex-offenders and recovering drug addicts to society.

Exemption for specified homes

5. Section 6 of the Act does not apply to the operator of a social residential home specified in the Schedule.
