Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 2) Order 2026 and comes into operation on 3 April 2026.

Declaration of precincts for Home Improvement Programme

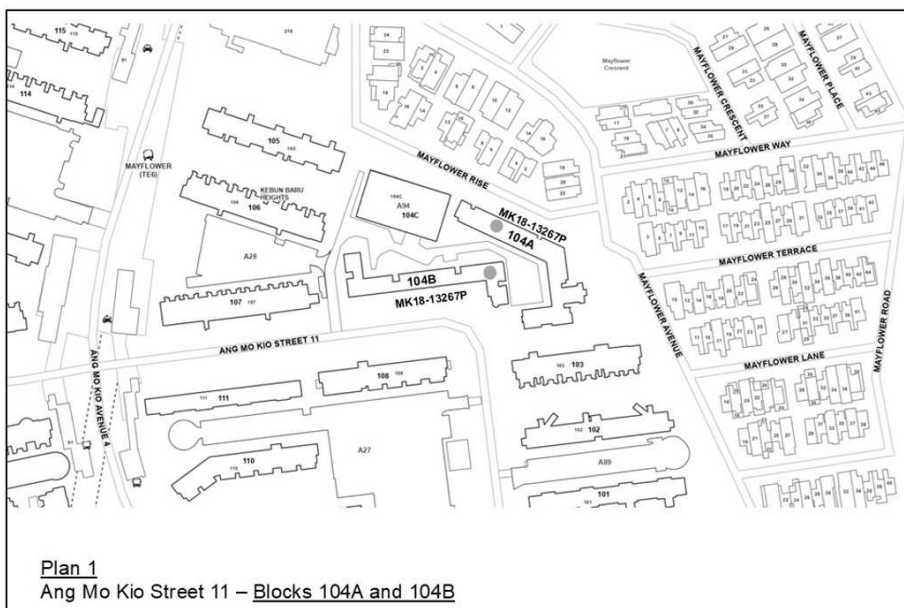
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purposes of carrying out upgrading works in connection with the Home Improvement Programme.

1. All that part of the housing estate of the Board bounded by Ang Mo Kio Street 11, Ang Mo Kio Avenue 4, Mayflower Rise and Mayflower Avenue, comprised in Lot number 13267P in Mukim 18 and on which Apartment Blocks 104A and 104B are erected, which blocks are each marked with a grey dot in Plan 1.

ANG MO KIO STREET 11

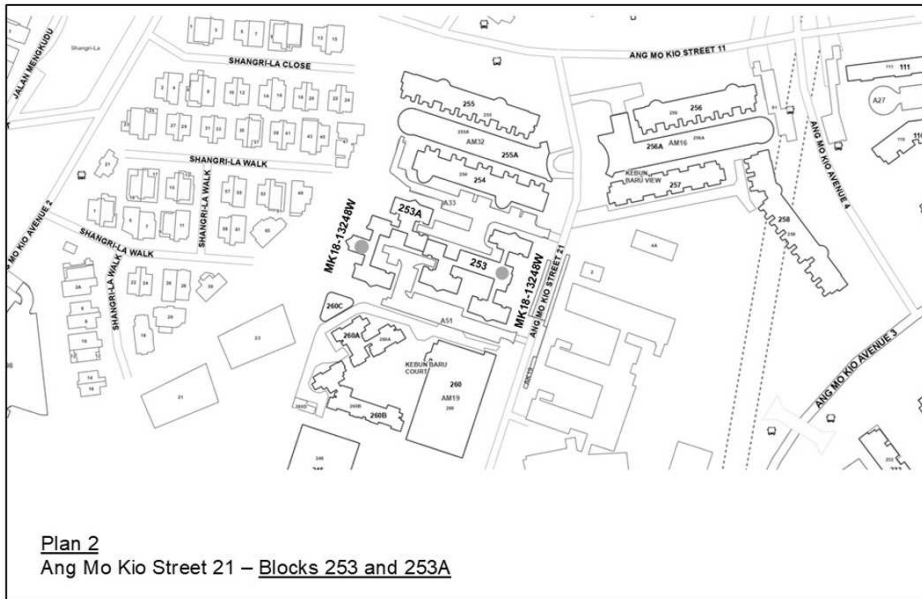

ANG MO KIO STREET 21

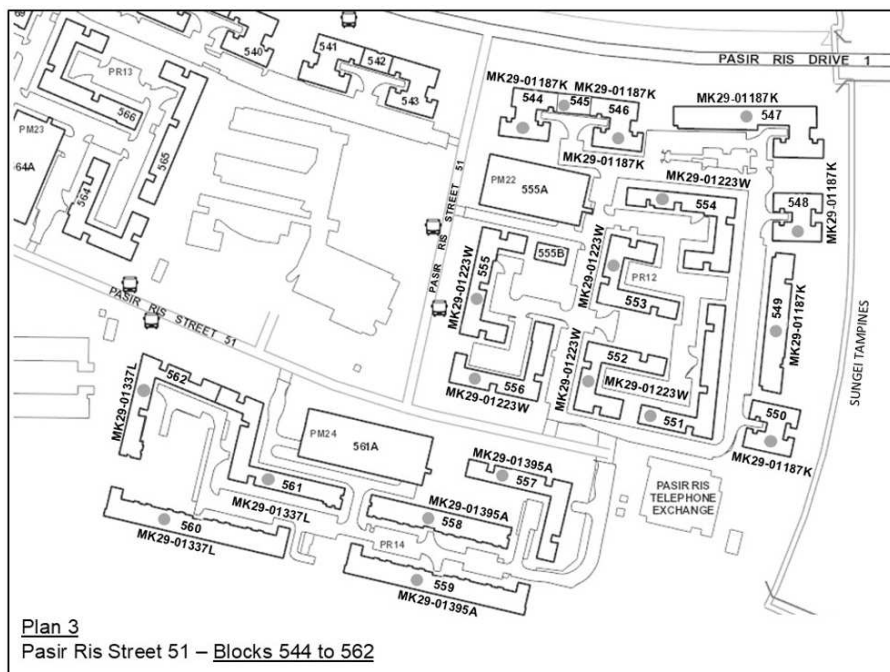

PASIR RIS STREET 51

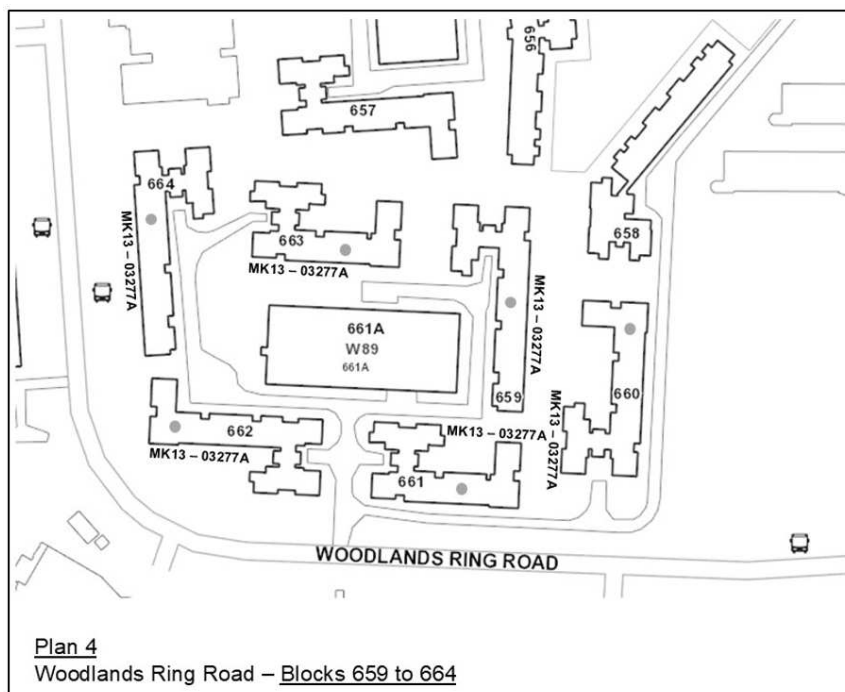
