PUBLIC TRANSPORT COUNCIL ACT 1987

PUBLIC TRANSPORT COUNCIL (STREET-HAIL FARE PRICING POLICY) (AMENDMENT) ORDER 2026

In exercise of the powers conferred by section 43(1) of the Public Transport Council Act 1987, the Public Transport Council makes the following Order:

Citation and commencement

1.—(1) This Order is the Public Transport Council (Street-hail Fare Pricing Policy) (Amendment) Order 2026 and, except for paragraph 6(1), comes into operation on 1 June 2026.

(2) Paragraph 6(1) is deemed to have come into operation on 31 December 2021.

Amendment of paragraph 9

2. In the Public Transport Council (Street-hail Fare Pricing Policy) Order 2020 (G.N. No. S 918/2020) (called in this Order the principal Order), in paragraph 9 —

- (a) in sub-paragraph (a), delete “or” at the end;
- (b) in sub-paragraph (b), replace “6 p.m.” with “5 p.m.”;
- (c) in sub-paragraph (b), replace the full-stop at the end with “; or”; and
- (d) after sub-paragraph (b), insert —
 - “(c) the period starting at 10 a.m. and ending before 2 p.m. on any Saturday, Sunday or public holiday, or another period substituted on variation under paragraph 13.”.

Amendment of paragraph 13

3. In the principal Order, in paragraph 13(1)(a), replace “or (b)” with “, (b) or (c)”.

Amendment of paragraph 18

4. In the principal Order, in paragraph 18 —

(a) in sub-paragraph (2), replace sub-paragraph (a) with —

“(a) \$8 if the hiring of the taxi begins on any day within the period starting at 5 p.m. and ending before midnight the same day; or”;

(b) in sub-paragraph (2)(b), replace “\$3” with “\$6”;

(c) in sub-paragraph (3), replace sub-paragraph (a) with —

“(a) \$5 if the hiring of the taxi begins on any day within the period starting at 7 a.m. and ending before 5 p.m. the same day; or”; and

(d) after sub-paragraph (7), insert —

“(8) Subject to paragraph 19, a location surcharge of \$5 is (if charged) payable for every journey, the hiring of which begins on any day at a public taxi stand at Mandai Wildlife Reserve, within the period starting at 1 p.m. and ending before midnight the same day.”.

Amendment of paragraph 19

5. In the principal Order, in paragraph 19(1) —

(a) in sub-paragraph (a), replace “or (5) or (6)” with “, (5), (6) or (8)”;

(b) in sub-paragraph (b), replace “or (5)” with “, (5) or (8)”.

Miscellaneous amendments

6.—(1) In the principal Order, in paragraph 2(1) —

- (a) in the definition of “public taxi stand”, replace “(Cap. 276)” with “1961”; and
- (b) in the definition of “taxi driver”, replace “Part V of the Road Traffic Act” with “Part 5 of the Road Traffic Act 1961”.

(2) In the principal Order, in the following provisions, delete “paragraph 5 and”:

Paragraph 7(1) and (3)

Paragraph 13(1)

Paragraph 14(1)

Paragraph 17(1)

Paragraph 19(1) and (2).
