CHILDREN AND YOUNG PERSONS ACT 1993

CHILDREN AND YOUNG PERSONS (REVIEW BOARD) (AMENDMENT) REGULATIONS 2026

In exercise of the powers conferred by section 118 of the Children and Young Persons Act 1993, the Minister for Social and Family Development makes the following Regulations:

Citation and commencement

1.—(1) These Regulations are the Children and Young Persons (Review Board) (Amendment) Regulations 2026 and, except for regulations 2(b), (c), (e) and (g), 5 and 7, come into operation on 1 July 2026.

(2) Regulations 2(b), (c), (e) and (g), 5 and 7 are deemed to have come into operation on 31 December 2021.

Amendment of regulation 2

2. In the Children and Young Persons (Review Board) Regulations 2011 (G.N. No. S 412/2011) (called in these Regulations the principal Regulations), in regulation 2 —

- (a) delete the definitions of “Chairperson”, “licensee” and “Vice Chairperson”;
- (b) in the definition of “home”, in paragraph (a), replace “section 52B” with “section 63”;
- (c) in the definition of “home”, in paragraph (b), replace “section 52P(2)” with “section 77(2)”;
- (d) replace the definition of “home” with —

““home” means a Government home for children and young persons or a licensed home for children and young persons;”;

- (e) in the definition of “licensee”, replace “section 52P(1)” with “section 77(1)”;
- (f) after the definition of “member”, insert —
 - ““Minister” includes any Permanent Secretary for the Ministry of Social and Family Development;”;
- (g) delete the definition of “Review Board”; and
- (h) in the definition of “resident”, replace the semi-colon at the end with a full-stop.

Amendment of regulation 3

3. In the principal Regulations, in regulation 3, delete paragraph (2).

Replacement of regulation 4 and deletion of regulations 5 and 6

4. In the principal Regulations, replace regulations 4, 5 and 6 with —

“Resignation of Board member

4. Any member of the Review Board may resign by giving written notice to the Minister.”.

Amendment of regulation 6

5. In the principal Regulations, in regulation 6(1), replace “section 52G” with “section 68”.

Replacement of regulation 7 and deletion of regulations 8, 9 and 10

6. In the principal Regulations, replace regulations 7 to 10 with —

“Quorum

7.—(1) The quorum for a meeting of the Review Board is 3 members.

(2) The quorum for a meeting of a committee of the Review Board is 3 members of the committee.

(3) No business may be transacted at a meeting of the Review Board or any of its committees if a quorum is not present.”.

Amendment of regulation 11

7. In the principal Regulations, in regulation 11(1)(b), replace “section 76(2)” with “section 102(2)”.

Amendment of regulation 12

8. In the principal Regulations, in regulation 12 —

- (a) in the regulation heading, after “to”, insert “Government”;
- (b) in paragraph (1), replace “home” with “Government home for children and young persons”; and
- (c) in paragraphs (2), (3), (4) and (5), replace “a home” with “a Government home for children and young persons”.

Deletion of regulation 13

9. In the principal Regulations, delete regulation 13.
