CORRUPTION, DRUG TRAFFICKING AND OTHER SERIOUS CRIMES (CONFISCATION OF BENEFITS) ACT 1992 (AMENDMENT OF SECOND SCHEDULE) (NO. 2) ORDER 2026

In exercise of the powers conferred by section 84 of the Corruption, Drug Trafficking and Other Serious Crimes (Confiscation of Benefits) Act 1992, the Minister for Home Affairs makes the following Order:

Citation and commencement

1. This Order is the Corruption, Drug Trafficking and Other Serious Crimes (Confiscation of Benefits) Act 1992 (Amendment of Second Schedule) (No. 2) Order 2026 and comes into operation on 1 May 2026.

Amendment of Second Schedule

2. In the Corruption, Drug Trafficking and Other Serious Crimes (Confiscation of Benefits) Act 1992, in the Second Schedule —

- (a) in Part 30, in item 647, in the first column, after “Section 15”, insert “(as in force immediately before 1 May 2026)”;
- (b) in Part 30, in item 648, in the first column, after “Section 16”, insert “(as in force immediately before 1 May 2026)”; and

(c) after Part 32, insert —

*“Part 33 — Offences included as serious offences
with effect from 1 May 2026*

Tobacco and Vaporisers Control Act 1993	
654. Section 15(6) for contravention of section 15(1)	Prohibition of import of chewing tobacco, certain prescribed tobacco products and their components
655. Section 15(7) for contravention of section 15(2)	Prohibition of sale, etc., of chewing tobacco, certain prescribed tobacco products and their components
656. Section 16(4) for contravention of section 16(1)	Prohibition of import of vaporisers and their components
657. Section 16(5) for contravention of section 16(2)	Prohibition of sale, etc., of vaporisers and their components
658. Section 16A(4) for contravention of section 16A(1) or (2)	Prohibition of import, sale, etc., of imitation tobacco products and their components
659. Section 19B	Import of Part 3A product containing specified psychoactive substance

660. Section 19C	Sale, etc., of Part 3A product containing specified psychoactive substance
661. Section 19H	Causing or procuring young person or vulnerable person to commit certain offences
662. Section 19I	Arranging or planning gatherings where Part 3A products containing specified psychoactive substances are to be used, etc.
