INTERPRETATION ACT 1965

INTERPRETATION (DELEGATIONS BY MINISTER FOR SOCIAL AND FAMILY DEVELOPMENT) (AMENDMENT) ORDER 2026

In exercise of the powers conferred by section 36 of the Interpretation Act 1965, the Minister for Social and Family Development makes the following Order:

Citation and commencement

1. This Order is the Interpretation (Delegations by Minister for Social and Family Development) (Amendment) Order 2026 and comes into operation on 1 July 2026.
