ORGANISED CRIME ACT 2015 (AMENDMENT OF SCHEDULE) ORDER 2026

In exercise of the powers conferred by section 80(1) of the Organised Crime Act 2015, the Minister for Home Affairs makes the following Order:

Citation and commencement

1. This Order is the Organised Crime Act 2015 (Amendment of Schedule) Order 2026 and comes into operation on 1 May 2026.

Amendment of Schedule

2. In the Organised Crime Act 2015, in the Schedule, in Part 1 —
(a) after item 189, insert —

“

Tobacco and Vaporisers Control Act 1993 — Offences included as serious offences with effect from 1 May 2026	
189AA. Section 3	Publication of advertisement relating to tobacco products, vaporisers and imitation tobacco products
189AB. Section 9	Promotion of sales of tobacco products
189AC. Section 9A	Implementation or conduct of shopper loyalty programme involving tobacco products
189AD. Section 10	Supply of tobacco products to under-aged person

189AE. Section 15(6) for contravention of section 15(1)	Importation of chewing tobacco, certain prescribed tobacco products and their components
189AF. Section 15(7) for contravention of section 15(2)	Sale, etc., of chewing tobacco, certain prescribed tobacco products and their components
189AG. Section 16(4) for contravention of section 16(1)	Importation of vaporisers and their components
189AH. Section 16(5) for contravention of section 16(2)	Sale, etc., of vaporisers and their components
189AI. Section 16A(4) for contravention of section 16A(1) or (2)	Importation, sale, etc., of imitation tobacco products and their components
189AJ. Section 19B	Importation of Part 3A product containing specified psychoactive substance
189AK. Section 19C	Sale, etc., of Part 3A product containing specified psychoactive substance
189AL. Section 19H	Causing or procuring young person or vulnerable person to commit certain offences
189AM. Section 19I	Arranging or planning gatherings where Part 3A products containing specified psychoactive substances are to be used, etc.

”; and

(b) before item 189A, in the heading, after “**1 September 2025**”, insert “**to 30 April 2026 (both dates inclusive)**”.
