Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 3) Order 2026 and comes into operation on 5 May 2026.

Declaration of precincts for Home Improvement Programme

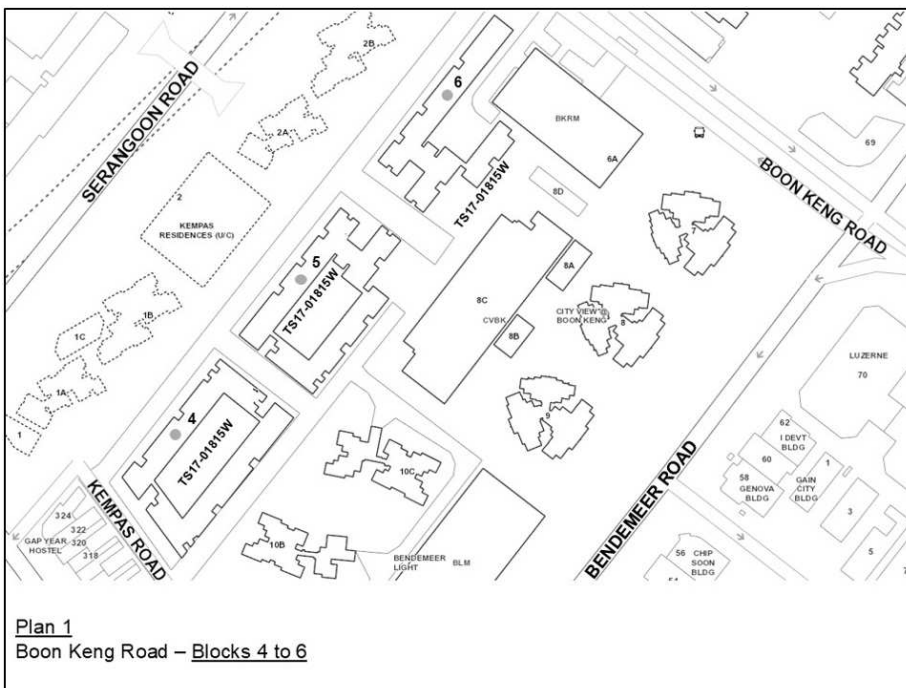
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purposes of carrying out upgrading works in connection with the Home Improvement Programme.

1. All that part of the housing estate of the Board bounded by Boon Keng Road, Bendemeer Road, Kempas Road and Serangoon Road, comprised in Lot number 01815W in Town Subdivision 17 and on which Apartment Blocks 4, 5 and 6 are erected, which blocks are each marked with a grey dot in Plan 1.

BOON KENG ROAD

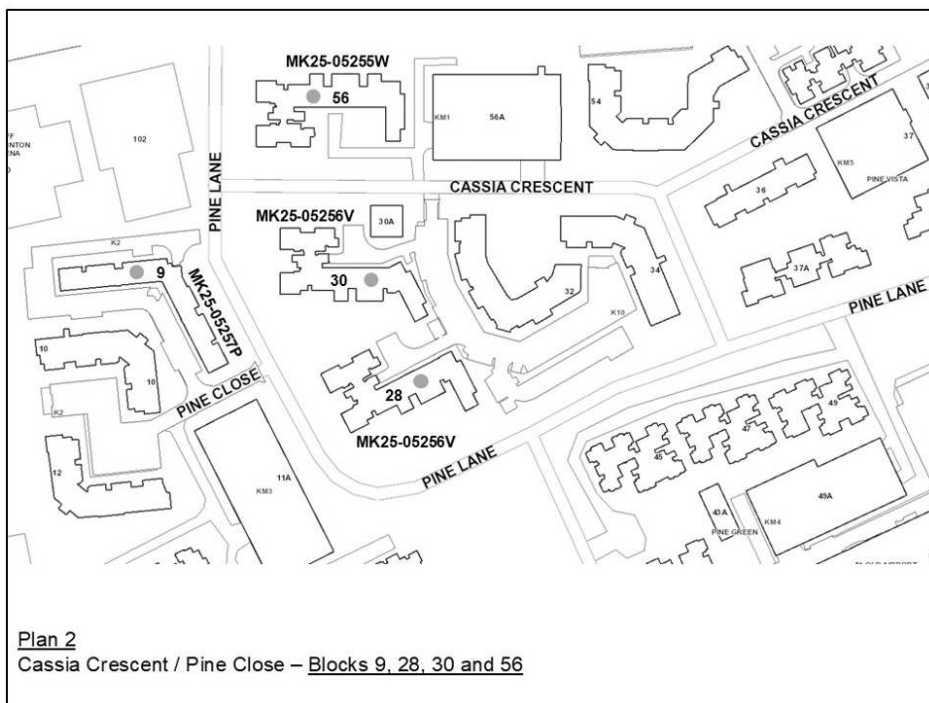

PLAN 2

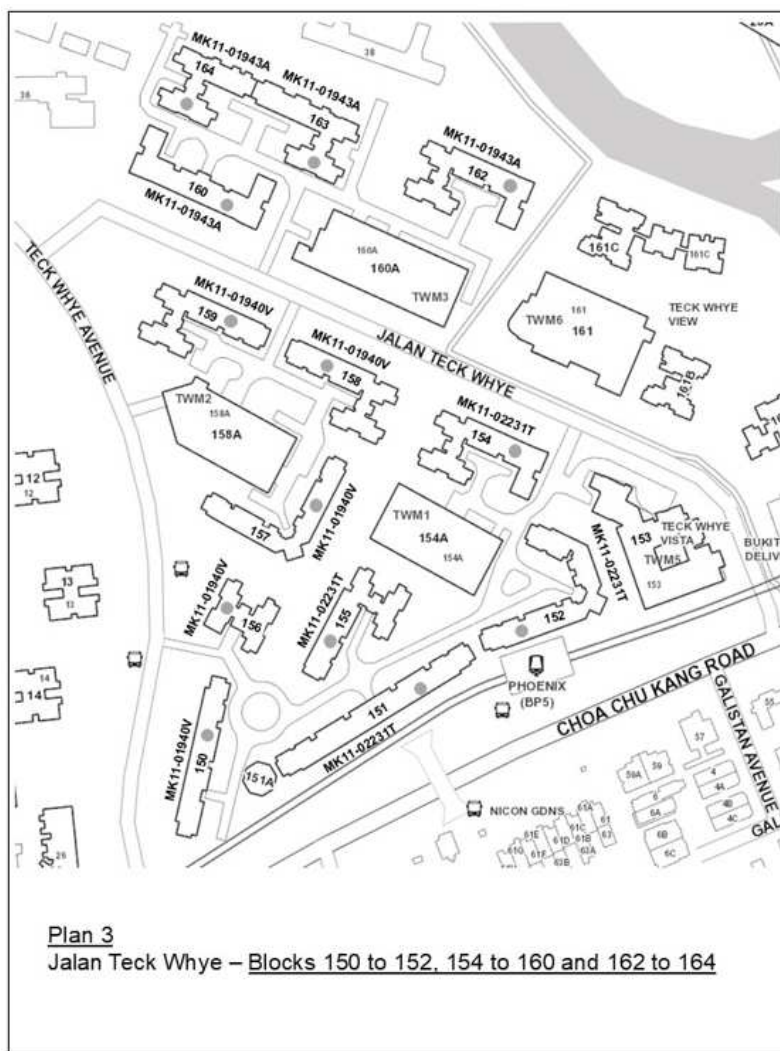
CASSIA CRESCENT / PINE CLOSE

JALAN TECK WHYE

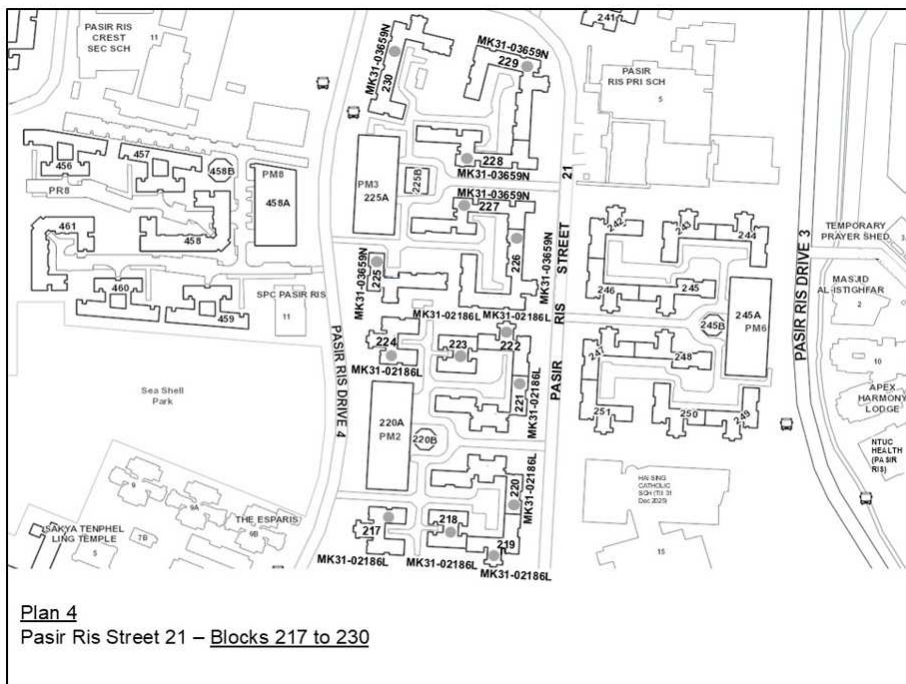

PLAN 4

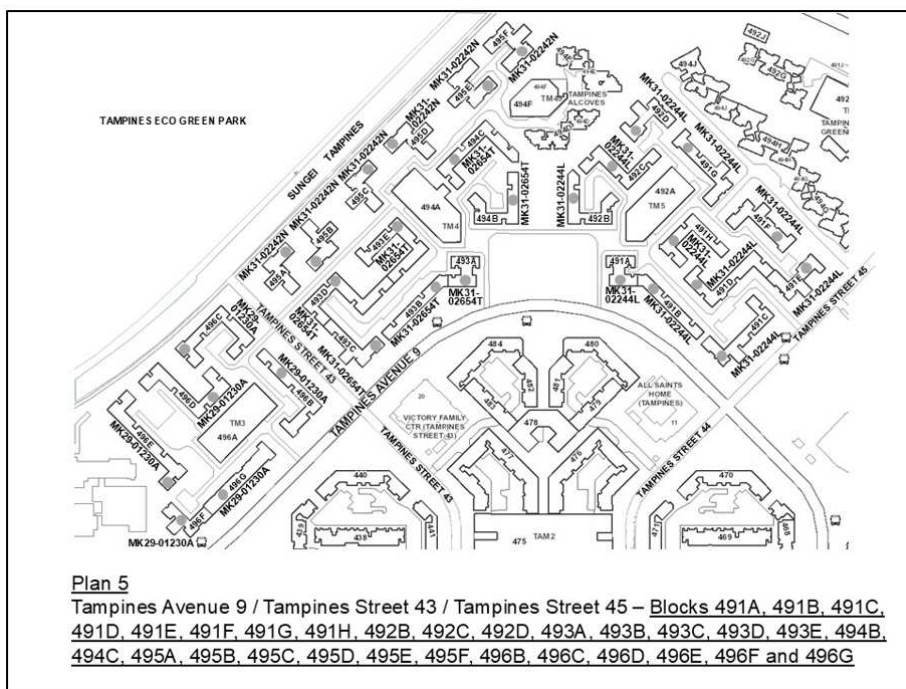
PASIR RIS STREET 21

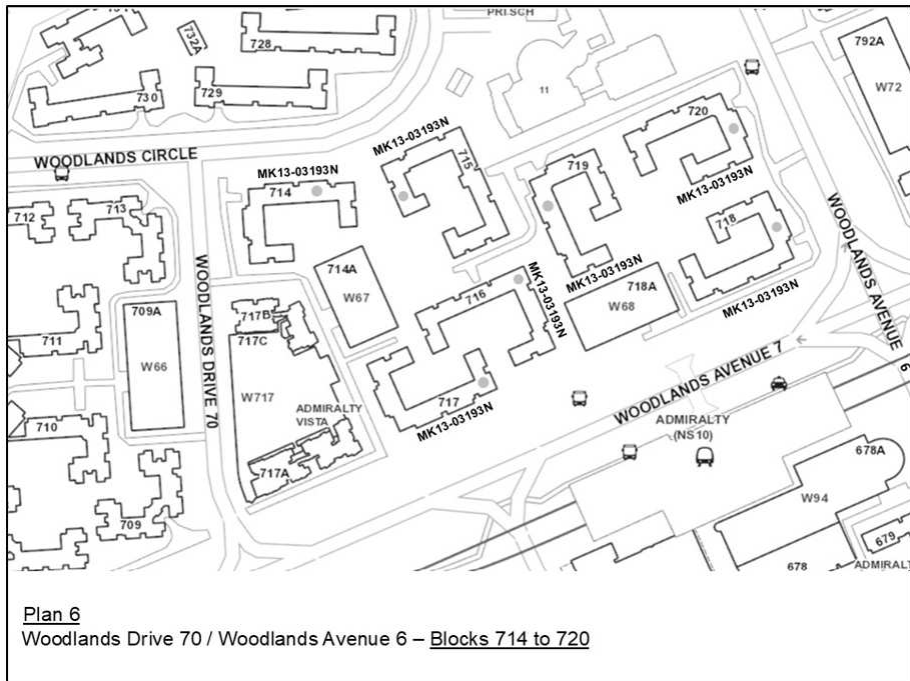
