CONSTITUTION OF THE REPUBLIC OF SINGAPORE

PUBLIC SERVICE (SPECIAL AND SENIOR PERSONNEL BOARDS) (AMENDMENT NO. 2) ORDER 2026

In exercise of the powers conferred by Article 110D(1) and (2) of the Constitution of the Republic of Singapore, the President, on the advice of the Prime Minister, makes the following Order:

Citation and commencement

1. This Order is the Public Service (Special and Senior Personnel Boards) (Amendment No. 2) Order 2026 and comes into operation on 1 June 2026.

Amendment of First Schedule

2. In the Public Service (Special and Senior Personnel Boards) Order 2010 (G.N. No. S 824/2010), in the First Schedule —

- (a) in items 1, 3 and 5, in the third column, delete “Mr Pang Kin Keong”;
- (b) in item 1, in the third column, after “Mr Aubeck Kam”, insert —
“Mr Joseph Leong Weng Keong
Mr Lai Chung Han”;
- (c) in item 2, in the third column, replace “Mr Pang Kin Keong” with “Mr Aubeck Kam”;
- (d) in item 2, in the third column, delete “Mr Tan Chye Hee”;
- (e) in item 2, in the third column, after “Ms Foo Chi Hsia”, insert “Mr Wong Kang Jet”;
- (f) in item 3, in the third column, after “Mr Wong Hong Kuan”, insert “Mr Tan Chye Hee”;

- (g) in item 4, in the third column, replace “Mr Chan Heng Kee” with “Mr Joseph Leong Weng Keong”; and
- (h) in item 5, in the third column, after “Mr Joseph Leong Weng Keong”, insert “Mr Wong Kang Jet”.
